Whereas, the Forest, Ecology and Environment Department, vide Indent No. FST/Ser/49/2020 dated 22.03.2020, forwarded the requisition for making direct recruitment to the **14 posts of Field Inspector**, UT Cadre, Level-6 (35400-112400), as per following break up:

Whereas, the requisite qualification for selection against the post, as per the Indent, is as under:

"3 year's diploma in Civil/Electrical/Mechanical/Environmental Engineering from Govt. recognized University Institution with at least 60% marks in aggregate"

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB), advertised the aforesaid 14 posts, as per the category-wise break up given herein above, vide Notification No. 03 of 2021 dated 04.06.2021, under Item No. 560, for seeking applications from the eligible candidates; and

Whereas, the JKSSB vide Notification No. JKSSB-COEOEXAM(UT)/83/2023-03-SSB (7309450) Dated. 16.10.2023, issued an Advance Notice for holding the OMR based written Examination for these posts on 22.10.2023 and after holding the exams, the Result/Score-sheet of the candidates was notified vide notification No. JKSSB-COEOEXAM(UT)/83/2023-03-SSB (7309450) dated: 08.11.2023; and

Whereas, the schedule of the Documents Verification (DV) of the candidates falling under the consideration zone were notified vide notification No. JKSSB-COEOEXAM(UT)/83/2023-03-SSB (7309450) dated: 19.11.2023, followed by Supplementary Document Verification (DV) vide No. JKSSB-COEOEXAM(UT)/83/2023-03-SSB (7309450) dated 23.12.2023; and

Whereas, the Board constituted a Selection Committee vide office Order No. 03-SSB of 2024 dated 03.01.2024, for preparing the Selection List for the said posts. The Selection Committee, so constituted, prepared the Provisional Selection List in accordance with the Merit/Eligibility of the candidates and as per the extant rules; and



Whereas, the Provisional Selection List, as prepared by the aforesaid Selection Committee, for the posts of Field Inspector, was placed before the Board at its 260th meeting held on 15.02.2024, which after deliberations, approved its notification.


Whereas, the Provisional Selection List, as prepared by the aforesaid Selection Committee, for these posts of Field Inspector, was subsequently notified vide No. JKSSB-SD0SECY(JMU)/9/2024-03 (E-7408343) dated 20.02.2024, seeking objections from the candidates; and

Whereas, after examination of the representations received to the Provisional List, the Board in its 263rd meeting held on 05.03.2024, deliberated and approved the proposal for notifying the Final Selection List for the aforementioned posts of Field Inspector, belonging to the Department Forest, Ecology and Environment.

Now, therefore, after taking into consideration all the aforementioned factors, the Final Selection List, along-with the waiting list, for the 14 posts of Field Inspector, UT Cadre, advertised vide Notification No. 03 of 2021 dated. 04.06.2021, under Item No. 560, is hereby notified as per **Annexure-A** to this Notification. It is further notified that:

- i. The above Final Selection List shall be subject to outcome of the OAs/Writ petition(s), if any, pending adjudication before any competent court of law.
- ii. The List shall also be subject to the outcome of such enquiry, involving any candidate(s), as figuring in this List.
- iii. The formal recommendations to the concerned Indenting Department shall be forwarded separately.
- iv. The candidate(s), whose recommendations are kept withheld, shall submit the requisite documents/certificates within a period of one month.
- v. The Selection of the candidates has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage.
