The JKSSB conducted the Written/ Skill Test for the aforementioned posts and, accordingly, as per the notified criteria, the Provisional Selection List was issued calling for objections from the aspirants.

Consequently, after due deliberations, the Board, in its 227th meeting, approved the Final Selection List for these posts, which was notified vide No. JKSSB /23/2023-03 (E-7164134) dated 30.05.2023.


