
Consequent upon the receipt of indent/requisition from the Department of Floriculture, Gardens & Parks, vide Indent No. Flori/ Refer/134/2015 dated 06.01.2021, the Jammu and Kashmir Services Selection Board (JKSSB), among other posts, advertised **04 posts** of Junior Assistant, vide Notification No. 02 of 2021 dated 26.03.2021, belonging to the Department of Floriculture, Gardens & Parks, under Item No.245, with the following breakup:

The JKSSB conducted the Computer Based Test (CBT) for these posts and, thereafter, on the basis of merit obtained by the candidates, the Document Verification was conducted. After seeking preferences from the candidates and on the basis of the principle of *Merit-cum-Preference*, the Revised Provisional Selection List for the said posts was notified vide Notification No.JKSSB-PLAN/25/2022-03 dated.30.12.2022.

Consequently, after due deliberations, the Final Selection List, was approved by the Board and subsequently notified vide Notification No.JKSSB-PLAN/25/2022-03 dated 21.02.2023.



Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, *the candidates whose recommendations are released by the Selection Agency shall submit their verification rolls in triplicate before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.*
