NOTICE

Whereas, you have been selected for the post of "Technical Assistant/ Technician (Anesthesia)" in the Health and Medical Education Department, (H&ME), GMC Baramulla, Divisional Cadre, Kashmir, pursuant to Advertisement Notification No. 02 of 2019 dated 01.02.2019, under Item No. 14 at Serial No. 02/waiting, under RBA category; and

Whereas, your recommendation for the aforesaid post was kept withheld subject to clarification concerning the time period during which you have completed your Bachelor in Arts (B.A) & Diploma in Anesthesia Assistant Course which were apparently overlapping; and

Whereas, the Jammu & Kashmir, Services Selection Board (JKSSB) vide communication No. SSB/Secy/Sel/27/A/2021/K/5361-63 dated 20.07.2022, has taken up the instant matter with Registrar, University of Kashmir and Registrar, State Para Medial Institute, Srinagar requesting them to kindly convey as to whether there was any provisions which permit a candidate to pursue B.A. and Diploma in Anesthesia Assistant/Technology as Regular candidate in the same session or otherwise; and

Whereas, the Registrar, University of Kashmir, vide letter No. F(SSB-Dual Course) EWSAcad/KU/22 dated 13.09.2022, and Registrar, State Para Medial Institute, Srinagar vide letter No. KPMC.GMC/SGR/3341-47 dated 25.08.2022, have intimated that you have obtained both the above Courses on regular basis, which is not permitted; and

Whereas, the referral for the instant posts was made prior to 31.10.2019 and, as such would be covered under the Administrative Council (AC) Decision No. 01 of 2022 (regarding withdrawal of posts); and


Whereas, you have approached the Hon'ble Central Administrative Tribunal, Srinagar in O.A. No. 837/2023, which has been disposed of by the Hon'ble CAT as under:

"...The petition is disposed of at pre-admission stage and it is provided that the respondents will dispose of the

representations, repeatedly filed by the petitioner, which are still pending before them for a decision.

In the process of deciding the representations by the respondents, opportunity of hearing to the petitioner shall be given to put-forth his case, as the same would uphold the doctrine of fairness. The consideration shall be accorded within a period of 6 weeks from the date of receipt of the copy of this order."

Now, therefore, in compliance to the above directions of the Hon'ble CAT, Srinagar, you are hereby informed through the medium of this Notice to submit your point of view within a period of **21 days** from the date of issuance of this Notice in the J&K Services Selection Board, CPO Chowk, Panjtirithi, Jammu/Zamzam Complex, Rambagh, Srinagar (as per your convenience).
