Whereas J&K Services Selection Board Pursuant to Advertisement Notification NO.01 of 2013, Dated 16.02.2013, under Item No.008, issued a **Selection List** of **07** Candidates (OM=04, RBA = 01, SC=01 & ST =01) with a wait list of **04** Candidates (OM=01, RBA= 01, SC=01 & ST = 01) and forwarded the recommendation to the indenting Department vide No.SSB/Secy/Sel/2017/1856-62, Dt.09.02.2017; and

Whereas JKSSB issued a Notification under endorsement NO.SSB/Sel/Secy/2016/8010-20, Dated 28.06.2016 sought preferences from the Candidates who on the basis of their score (in the written test) were shortlisted in multiple/more than one item Nos. for the post of Demonstrator Electrical, Vocational Instructor Mechanic Auto Electrical & Electronics (Technical Education Department)/Junior Engineer Electrical. However, no such preference/consent was sought from the candidates shortlisted for the post of Demonstrator Electronic & Communication Engineering, (Technical Education Department) State Cadre, Item NO.008, (01 of 2013) as the syllabus of the post was different and separate exam was conducted for the post; and

Whereas while issuing the aforementioned selection list , the candidates who were already selected for the post of JE Electrical (PDD) under Item No.056, **02 of 2015 State Cadre were not considered for selection** for the post of **Demonstrator Electronics & Communication Engineering (Technical Education Department), State Cadre, Item NO.008, 01 of 2013** ; and

Whereas a Candidate namely Zahid Farooq Lonn,S/O Mohd Akbar Lonn who had been selected as JE Electrical (Item No.056, 02 of 2015) represented before the Board with the plea that the Board never sought preference from the Candidates in respect of JE Electrical & Demonstrator Electronics & Communication; and

Whereas the issue was discussed in the Board on 16.02.2017 and it was decided that the selection list in respect of Item NO.008 (01 of 2013) for the post of Demonstrator Electronic & Communication Engineering (Technical Education Department) State Cadre issued vide No.SSB/Secy/2017/1856-62, Dated 09.02.2017 be withdrawn abinitio and reframed, as no consent/preference notification in the matter had been issued by the Board; and

Now therefore, in view of the situation enumerated here- in above, the selection list for the post of Demonstrator Electronics & Communication Engineering (Technical Education Department) State Cadre under Item NO.008 (01 of 2013) issued vide endorsement No.SSB/Secy/Sel/2017/1856-62,Dt.09.02.2017 is hereby withdrawn abintio and the revised selection list for the said post is hereby issued as per annexure “A”, thereby considering the candidates falling within the selection zone on the basis of their respective overall merit, irrespective of the fact that such Candidates have already got selected for the post of JE. Electrical under Item No.056 (02 of 2015) State Cadre. However, other terms and conditions as laid down in the earlier communication shall remain intact.
