- Against indent No. [ET/Estt/154/2012](#) Dated: - 11.08.2015, Board advertised 18 posts (OM=09, RBA=04, SC=02, ST=02, ALC=01) of "**Jr. Scale Stenographer**", **Divisional Cadre Kashmir**, in pursuance to the advertisement notification 05 of 2015 (Item No. **197**). - On the basis of points obtained in type test and short hand test, weight-age determined in accordance with selection criteria and the interview awards, select list so framed on the basis of merit was approved by the Board.
- The undersigned is directed to enclose the select list/recommendation as Annexure "A". This select list shall be subject to outcome of any writ petition(s), if any, pending in any court of the competent jurisdiction.
- That the Board is devoid of any fool proof mechanism/resources to verify the recognition status/genuineness of qualification/category certificates/ permanent resident certificate/ Domicile Resident of concerned District for a period not less than 15 years except Schedule Caste Category. Therefore, the indenting department shall have to verify position confidentially from the concerned Universities/ Institutions/departments.
- You are further requested that in case any certificate/document during the course of verification turns out to be fake/fictitious, the Board may kindly be kept posted with such outcome so that criminal proceedings against such candidates are initiated.
