NOTIFICATION

(Shorthand-Test - Jr. Scale Stenographer)

1. SHORTHAND-TEST (Dictation and Transcription) of the candidates who have qualified the "TYPE-TEST for the posts of Junior Scale Stenographer, Divisional Cadre Kashmir, (009/04 of 2017), (014/04 of 2017) and (016/04 of 2017 (Various Departments), shall be conducted on 19<sup>th</sup> July 2018 at NIELIT (formerly DOEACC), Old Airport Road, Rangreth, Budgam, as per the candidates / items shown at Annexure "A" of this notice
2. The Shorthand-test schedule and particulars of the candidates are annexed as Annexure "A" for Kashmir Centre candidates. The same is also available in the offices of the Administrative Officer, J&K Services Selection Board, Division Office, Jammu / Srinagar. The schedule and particulars of the qualified candidates is also available in the official web site of SSB i.e [www.jkssb.nic.in](http://www.jkssb.nic.in).
3. The candidates shall have to produce all original certificates / testimonials before the responsible official of the Board, failing which he/she will lose the right to sit in the Shorthand- Test. A photocopy of each such certificate duly attested by the Gazetted Officer with his / her seal and signature of the officer or self-attested by the candidate shall be deposited with the Staff. Further, in case of any deficiency with reference to eligibility is proved, the candidate shall not be considered for selection and will be treated as ineligible and disqualified.
4. Any candidate found guilty of impersonating or submitting fabricated / tampered documents / testimonials or making false, incorrect or suppressing material information shall render him / her liable for criminal prosecution under law and may be debarred permanently or for a specific period for consideration of any or all recruitments made by the Board. Also canvassing / lobbying in any form will entail disqualification of the candidate(s).
5. A candidate, who fails to appear in the test on the scheduled date & time, shall not be allowed to appear in the test for the mentioned notification on any subsequent date and shall be disqualified for any further consideration on this account.
6. No supplementary Shorthand-test (of the candidates who happen to miss their Shorthand-test scheduled herein) shall be conducted by the Board, in whatsoever circumstances.

NOTE:-

- a. No TA / DA shall be paid by the Board for appearing in the Shorthand-test.
- b. All the candidates shall report at least one hour earlier before the start of the test and if any candidate(s) reports after the start of the said test he / she will not be allowed to appear in the said Shorthand-test and no claim in this regard shall be entertained at any stage.
- c. Candidate(s) must bring 2 passport size photographs to be pasted on Answer sheet /Admit Card.

- d. The candidates shall also bring a Photo Identity Cards/Document acceptable as their identity proof.
- e. Mobile Phones are not allowed in Examination Hall.
