Whereas, the J&K Service Selection Board has forwarded the select list of the candidates for the post of Teacher District, Cadre, Rajouri under item No. 397, 494 and 555, vide this office letter No. SSB/Sel/Sel/Secy/015/5807-14 dated 22.06.2015, under Notice No.'s 03 of 2012, 05 of 2013 and 06 of 2013, respectively.

Whereas, the candidate namely Pryanika Sharma D/o Sohan Lal figuring at S. No. 07 and Lobna Jabin D.o Mohd Adris Khan, figuring at S. No.47, (waiting list) at item No. 494(05 of 2013)

Whereas, as per records Pryanika Sharma D/o Sohan Lal has appeared in the written test under Roll No. 116141458 for item Nos. 397 (03 of 2012) and 494 (05 of 2013) and has been subsequently shortlisted and interviewed for item No. 494 (05 of 2013) on the basis of her score in the written test. Further, the candidate has been allotted another Roll No. 116141458, wherein her name is spelled as "Priyanaka Sharma" for item No. 555(06 of 2013). The first Roll Number 116141458 stands tagged with her 2nd Roll Number 116141488. Therefore, the candidate has also been shortlisted for item No. 555 (06 of 2013) under Roll Number 116141448, at Interview S. No. 1558. for which candidate has been marked as absent by selection Committee.

Whereas, similarly, as per records Lobna Jabin D/o Mohd Adris Khan, has appeared in the written test under Roll No. 116137166 for item No. 397(03 of 2012) and 494 (05 of 2013) and Roll No. 116137185 for item No. 555 (06 of 2013) owing to the fact that her name is spelled differently (Lobna Jabin and Lubna Jabin). The candidate shortlisted/interviewed for item No. 494 (05 of 2013) on the basis of her score at Interview S. No. 846. While as at the 2nd Roll No. 116137185 (for item No. 555, 06 of 2013), has been marked as Absent by the Convenor Selection Committee.

Whereas, both the candidates have represented before the Board, claiming that they have appeared in the common written test, conducted by the Board for item No. **397, 494 and 555 respectively. Subsequently, the Board has conducted common Interview for these three items who have qualified the written as per 1:5 ratio.**

Whereas, vide letter No. SSB/Sel/SEcy/2015/7008-09 dated 31.07.2015, the two posts of Teacher, at item No. 555 were kept on hold for making placement of suitable candidates.

Whereas, both the candidates namely Pryanka Sharma D/o Sohan Lal figuring at S. No. 07 under OM category (60.6442 points) and Lobna Jabin D.o Mohd Adris Khan, fguring at S. No.47 under OM category (57.8970 points), (waiting list) at item No. 494(05 of 2013), has also making grade in the Item No. 555(06 of 2013)

Whereas, the matter was processed and Board approved to place these two candidates in the item No. 555(06 of 2013), at S. No. 52/OM and 187/OM.

In view of the above backdrop of the situation enumerated herein above, the candidates Pryanka Sharma D/o Sohan Lal, having (60.6442 points) has been now selected/recommended at S. No. 52 under OM category and Lobna Jabin D.o Mohd Adris Khan, having (57.8970 points) has been selected/recommended at S. No. 187 under OM category at item No. 555 (06 of 2013), against the two posts which were kept on hold vide above referred letter. The revised serial/merit position shall be communicated lateron.

However, other terms and conditions shall remains the same conveyed vide letter No. SSB/Sel/Sel/Secy/015/5807-14 dated 22.06.2015.
