Subject:- Selection list under SRO-202 for the post of Forest Guard, Forest Department Item No. 455 Notification No. 06 of 2015 dated 01.09.2015 (District Cadre Srinagar).

Sir,

Whereas, (Forest Department) vide indent No. (FST/Coord/69/2012) dated 06.08.2015 referred (31) posts of Forest Guard with category breakup of (OM=19, RBA=06, SC=02, ST=03 and ALC=01) in District Cadre Srinagar to the J&K Services Selection Board for selection; and

Whereas, the posts were advertised by the Board vide Notification No. 06 of 2015 dated 01.09.2015 and selection process in respect of the same commenced and a provisional short list of the candidate(s) was published by the Board on 14-02-2018 and the said candidates were called for document verification/Counseling; and

Whereas, the Board conducted the Document Verification-cum-Counseling of the provisionally shortlisted candidate on 09-03-2018 & 10.03.2018 as per the schedule published/uploaded on official website; and a select list of 30 candidates was framed/finalized and approved in terms of the SOP of the Board; and

Whereas, before said selection list could be forwarded to the Indenting Department, it came to fore, that the matter was sub-judice and the Hon'ble High Court in SWP No. 575/2018 titled Qurtipa V/s State J&K SSB & Others and Hon'ble High Court had passed an interim order dated 18.07.2018 for reserving 01 post of Forest Guard from the Open Merit Category; and

Whereas, the matter was placed in the 140th Board meeting for appropriate consideration in light of the interim orders of the Hon'ble High Court wherein, the Board decided to reserve 01 post of Forest Guards from the Open Merit Category in compliance aforementioned order of the Hon'ble High Court.

Now, therefore, in pursuance to the provisions contained in J&K Services Selection Board Conduct of Examination Regulations, 2013 issued vide Government Order No. 1465 – GAD of 2013 dated 15.10.2013 as well as the approval of the Board;


- I. The final selection list for the post of (Forest Guard) advertised under Item No. (455), Notification No. (06 of 2015) dated (01.09.2015) is hereby notified as **Annexure-"A"**.
- II. The selection list comprises of 30 candidates under (OM=19, RBA=06, SC=02 and ST=03) alongwith waiting list of 20 candidates under OM=13, RBA=04, SC=01 and ST=02) categories.

- III. 01 post under OM Category kept reserved in compliance to the direction of Hon'ble High Court in SWP No. 575/2018 titled Qurtipa V/s State J&K SSB & Others.
- IV. 01 post under ALC category remained unfilled due to non-availability of eligible candidate and same is returned with the request to kindly furnish the fresh indent or confirm for re-advertising the same, if required.
- V. The physical fitness certificate shall further be verified by the indenting Department.
- VI. The list notified shall be subject to the outcome of writ petition(s) (if any) pending disposal before any Competent Court of jurisdiction/forum.

The documents verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of category/degree certificate in reference of advertised notification and establishing the genuineness/validity or otherwise of the same shall be responsibility of appointing authority.

You are further requested that in case any certificate/document during the course of verification turns out to be fake/fictitious, the Board may kindly be kept posted and appropriate criminal proceeding against the such candidates may please be initiated.
