
The appointee shall report to the Administrative Officer, J&K Services Selection Board, Divisional Office Jammu, within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates in original to be verified subsequently:-

1. Academic Qualification certificate.
2. Age and Health certificate.
3. Permanent Resident Certificate..
4. No Loan certificate under Self-Employment scheme from DIC concerned and Employment Department.
5. Dependent certificate issued by the Assistant Commissioner, Revenue.
6. All the relevant documents as are required under SRO-43 of 1994.

The appointee shall be initially on probation for a period of two years and if, on verification, the certificate (s) produced by the appointee prove to be fake or forged, the appointment shall be treated to have been cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report about the verification of his character and antecedents are received from the Addl. Director General of Police, CID, to whom a reference shall be made by the Administrative Officer, J&K, Services Selection Board, Divisional Office, Jammu. He shall furnish on affidavit to the effect that in case any adverse report about his character and antecedents from the Addl. Director General of Police, CID or in respect of certificates to be verified, is received, he shall no right to claim the appointment and his appointment as Orderly (Class-IV) in J&K Services Selection Board shall be deemed to have been cancelled abintio.
