Subject:- Cancellation of Select, ~~list~~ of candidates for the post of "Dental Assistant/Junior Dental Technician" (Health & Medical Education department), District Cadre Budgam.

Whereas, the J&K Services Selection Board has issued the select list of the candidates for the post of Dental Assistant/Junior Dental Technician" (Health & Medical Education department), District Cadre Budgam advertisement Notification No. 07 of 2013 and 10 of 2013, item Nos.642 and 798 respectively and forwarded to the Health and Medical Education Department vide letter No. SSB/Sel/Secy2015/7531-38 dated 10.08.2015 for further course of action.

Whereas, a complaint has been received by the Board wherein it has been alleged that the candidates figuring at S.No.03/OM, item No.642 (07 of 2013) namely Javeid Ahmed Dar S/o Ghulam Mohd Dar R/o Hyderpora, Budgam is not falling under the jurisdiction of District Budgam.


Whereas, the matter with regard to residential district was taken up with the Deputy Commissioner Budgam vide this office letter No.SSB/Sel/Secy/2015/8339-41 Dated 24.08.2015 with the request to kindly intimate whether the above mentioned candidate is residing in District Budgam or otherwise.

Whereas, in response to our letter No. referred to above, the Deputy Commissioner Budgam vide letter No DCB/SQ/15/915 dated 28.08.2015 conveyed as under:-

It has been found that Javid Ahmad Dar S/o Ghulam Mohammad Dar is resident of village Hyderpora, the village Hyderpora was upto 2007 within the jurisdiction of Tehsil and District Budgam but after issuing of SRO 185 of 2007 dated 22.05.2007, the village Hyderpora now falls within the jurisdiction of Tehsil South District Srinagar.

Whereas, the issue was processed by the Board and Board has decided that as intimated by the Deputy Commissioner Budgam, vide aforesaid communication, the selection of the candidate may be cancelled and the candidates falling next in order of merit may be considered against the said post

In the backdrop of the situation enumerated hereinabove, the selection of Javeid Ahmed Dar S/o Ghulam Mohd Dar R/o Hyderpora, Budgam S.No.03/OM, item No.642 (07 of 2013) is hereby cancelled abinitio.
