Subject:- Provisional Shortlist of candidates under Ex-Servicemen category for the posts of Jr Employment Officer, (Labour & Employment Department), State Cadre, Advt/Item No. 05/2017/002), for counselling and document verification.

1. In continuation to this office Notice issued under endorsement No SSB/Secy/Sel/2018/9961-65 dated 13.09.2018, the candidates shown at annexure "A" of this notice are provisionally shortlisted under Ex-Servicemen category for the posts of Jr Employment Officer, (Labour & Employment Department), State Cadre, Advt/Item No. 05/2017/002, for which examination held on 1st July, 2018.
2. The candidates figuring in Annexure "A" to this notice have been provisionally shortlisted for counselling cum document verification on the basis of merit acquired in the written test. It may be noted that the candidates figuring in document verification are three times the actual number of posts and as such no candidate figuring in the enclosed annexure would have any claim to his/her inclusion in the final selection list, simply on the ground of figuring in this provisional shortlist.
3. The candidates figuring in the provisional shortlist shall have to appear before the Counselling Cum Document Verification Committee, the dates for which shall be notified separately by the J&K Services Selection Board, with the following documents in original:-
 - Copy of Online Application form.
 - D.O.B Certificate.
 - Discharge certificate in case of Ex-serviceman category.
 - Other documents as per the advertisement.
 - Bonafide certificate on the format prescribed by the Board duly issued by the Controller /Registrar of the concerned University in respect of candidates, who have obtained degrees from the Universities/ Colleges outside the State of J&K, other than Central Universities.

4. Additionally the candidates are also required to produce a self-attested photocopy of each documents/ certificates/bonafide/Online application form on the day of counselling and document verification.
5. Candidates are figuring in reserve categories, purely on the basis of details they have incorporated in their data i.e online application form. Their respective claims on this account are further subject to production of valid reserve category certificate at the time of counselling and document verification, in addition to the normal process of verification indicated at para 03.
