Subject:- Selection of the candidate for the post of Accounts Assistant  
(Finance Department) District, Cadre Baramulla.

Whereas, the J&K Services Selection Board has forwarded a select list of the candidates for the post of Accounts Assistant District Cadre Baramulla vide office letter No.SSB/Sel/Secy/2015/3589-94 dated 31.03.2015 to the Finance Department in terms of vacancies referred and notified vide advertisement Notice No. 10 of 2013, item No.790.


Whereas, amongst others, the selection of one candidate namely **Lateef Ahmad Najar S/o Gh. Qadir Najar (figuring at S.No 01/OSC category), item No.790 (10 of 2013)** was kept withheld and is subject to production of valid category certificate.

Whereas, the said candidate has failed to submit his documents for release of recommendation for the post of Accounts Assistant District Cadre Baramulla.

Whereas, the candidate namely **Lateef Ahmad Najar S/o Gh. Qadir Najar (figuring at S.No 01/OSC category), item No.790 (10 of 2013)** has submitted an undertaking in the shape of Affidavit duly attested by Judicial Magistrate 1<sup>st</sup>. Class Pattan wherein it has been stated that the deponent is already working as Teacher in Education department and has no objection if the department concerned shall appoint any other candidate on the said post.

Whereas, a final notice was issued under endorsement No SSB/Sel/ Secy/ 2015/ 8651-53 dated 28.08.2015 giving final opportunity to the above said candidate to submit the relevant papers within a weeks time from the date of issuance of the notice otherwise he will forfeit his selection. No response has been received from the said candidate till date.

Therefore, in view of the aforementioned circumstances, the withheld selection of **Lateef Ahmad Najar S/o Gh. Qadir Najar (figuring at S.No 01/OSC category), item No.790 (10 of 2013)** for the post of Accounts Assistant District cadre Baramulla in pursuance to advertisement Notice No.10 of 2013, item No.790 has been **cancelled/withdrawn abinitio**.
