Subject:- **SWP No.2106 /15 titled Farkanda Waheed Vs State & Ors.**

Whereas the Services Selection Board issued Advertisement notification No.03 of 2012,05 of 2013 and 06 of 2013 under item No 502 advertised the post of Teacher District Cadre Doda.

Whereas the petitioner had applied in all the notifications.

Whereas the petitioner was not considered for notification No.06 of 2013 under RBA category because of her candidature was considered only in 03 of 2012,05 of 2013

Whereas after perusal, it was observed that her OMR form was tagged with another form as such her candidature was not considered in notification NO.06 of 2013.

Whereas she has filed a writ petition bearing SWP No.2106/15 in which she prayed that she had secured more points than the last selected candidates and has applied in all the notification, as such she may be considered for appointment/selection against the post of Teacher District Cadre Doda pursuant to notification NO.06 of 2013 as she is making the grade in the said selection process.

Whereas after perusal of merit position of the petitioner and as well as OMR form she has applied in all the notification including notification NO.06 of 2013 and has secured 59.8502, while as the last selected candidate 59.5487.

Whereas the Hon'ble High Court vide its order dated 22.7.2015 has reserved one post of General Line Teacher District Doda pursuant to Advertisement notification No.06 of 2013 dated 10.5.2013.

Keeping in view of the above position of the case as well as the orders of the Hon'ble High Court the petitioner has applied to Advertisement notification No.06 of 2013 dated 10.5.2013 as well, and has secured 59.8502 while as last selected candidates 59.5487 hence the petitioner making the grade in the selection. As such Farkhanda Waheed D/o Ashraf Ali Kelu R/o Village Chakka Tehsil Bhandarwah Distt Doda is here by recommended to the post of General Line Teacher Dsitt Cadre Doda pursuant to notification No.06 of 2013 dated 10.5.2013. The merit position is enclosed.
