

Whereas, in response, the Relief & Rehabilitation Commissioner (M) Jammu vide letter No. RRCM/PS/15/829 dated 15.12.2015 conveyed as under:-


It is to be intimated that the certificate in favour of Amrita Razdan D/o Rattan Lal Razdan R/o Shalla Kadal, Srinagar A/P Gulshan Nagar, Natipora, Srinagar has been issued by their office as per SRO 412. It is further clarified that it comes within the purview of Hon'ble Prime Minister's Employment package announced for the unemployed youth of Kashmiri Migrants.
