Sub:- Select list of the candidates for the post of Accounts Assistant (Finance Department) Divisional cadre Kashmir, advertised vide Advertisement No. 01 of 2012 dated 19-07-2012, Item No. 053, under Hon'ble Prime Minister's Special Package for Kashmir Migrants.

Whereas, the J&K Services Selection Board has issued the select list of the candidates for the post of Accounts Assistant (Finance Department) Divisional cadre Kashmir, advertised vide Advertisement No. 01 of 2012 dated 19-07-2012, Item No. 053, under Hon'ble Prime Minister's Special Package for Kashmir Migrants and forwarded to the Revenue Department vide letter No. SSB/Sel/Secy/2015/3603-08 dated 31.03.2015 for further course of action.

Whereas, a slot at **S.No. 01-Waiting under OM category** was kept blank owing the fact that the candidate making grade for selection at the said serial was having internally displaced certificate issued by the Relief and Rehabilitation (M) vide No. No .RRCM/HQA/ID/10/156 Dated 26-5-2010.

Whereas, the case was placed before the Board in its 121<sup>st</sup> Board meeting and after threadbare discussion the Board has decided that the matter may be taken up with the Relief & Rehabilitation Commissioner (M) regarding consideration of certificate.

Whereas, the matter with regard to clarification regarding consideration of internally displaced certificate was taken up with the concerned quarter vide this office letter No.SSB/Sel/Secy/2015/3669 dated 06.04.2015.

Whereas, in response, the Relief & Rehabilitation Commissioner (M) Jammu vide letter No. RRCM/PS/15/857 dated 22.12.2015 conveyed as under:-

It is to be intimated that the certificate in favour of **Sunil Kumar Raina S/o Roshan Lal Raina R/o Tral Payeen District Pulwama A/P Noorpora Tral Kashmir** has been issued by their office as per SRO 412. It is further clarified that it comes within the purview of Hon'ble Prime Minister's Employment package announced for the unemployed youth of Kashmiri Migrants.

Therefore, in view of the aforementioned circumstances, I am directed to convey that the recommendation of the candidate namely **Sunil Kumar Raina S/o Roshan Lal Raina R/o Tral Payeen District Pulwama** whose full particulars are appended at **annexure "A"** to this order is hereby released as per the terms and conditions already conveyed vide letter No. SSB/Sel/Secy/2015/3603-08 dated 31.03.2015 for further course of action.
