**Subject: - Select list of candidates for the post of “Physical Education Teacher” (Technical Education / YSS Department), District Cadre Samba.**

Whereas, in terms of communication No. SSB/Sec/Sel/2016/2565-71, Dated 12.02.2016, the J&K Services Selection Board has forwarded the select list of the candidates **for the post of “Physical Education Teacher” (Technical Education / YSS Department), District Cadre Samba under Item No. 728 (09 of 2013).**

Whereas, among others, **Mr. Sarvan Kumar S/o Bishan Dass R/o Bhatyari Katlam, Samba** was recommended at **S.No. 8 under Open Merit** in the aforementioned list.

Whereas, while framing the selection list for the item number (in question), due to an **in-advertent error**, the written examination score **117.7850** (out of 150) of roll number **1311600679** has been **reflected** against the candidate namely **SARVAN KUMAR (Roll No. 1321600679) while as** his actual score in the written examination is **80.5369** (out of 150).

Whereas, due to this **in-advertent error** Mr. Sarvan Kumar has wrongly find place in the selection zone of item No. 728 (09 of 2013) under Open Merit at S.No. 8.

Now therefore, in view of the situation summed-up herein above, the **selection of Mr. Sarvan Kumar S/o Bishan Dass R/o Bhatyari Katlam, Samba figuring at S.No. 8 under Open Merit of item No. 728(09 of 2013) is hereby withdrawn abinitio.** Consequently, S.No. 9 will now become S.No.8, S.No.10 will now become S.No. 9 so and so forth up-till S.No. 20 now becoming S.No.19, thereby paving way for the candidate namely **AMIT SHARMA (Roll No. 1311600100, Int.S.No. 7) figuring at waiting S.No.1, to enter in to the selection zone at S.No.20.** Further, waiting S.No.2 shall now become S.No.1 and S.No.3 shall now become S.No. 2.
