**Subject:- Revised Select list of candidates for the post of “Junior Physiotherapist” (Health & Medical Education Department), Divisional Cadre Kashmir pursuant to Advertisement Notification No. 03 of 2012 dated 28.12.2012, item No. 158.**

Whereas, the J&K Services Selection Board has issued the select list of the candidates for the post of **Junior Physiotherapist** (Health & Medical Education Department), Divisional Cadre Kashmir pursuant to advertisement notification No. 03 of 2012 dated 28.12.2012, (item No.158) vide letter No. SSB/Sel/Secy/ 2015/11095-11102 dated 21.10.2015.

Whereas, the case was placed before the Board, and it was decided to cancel the selection of the candidates whose internship completion certificates are issued after cut-off date.

Whereas, the recommendation of the above said candidates were cancelled vide this office order No.587-SSB of 2015 dated 30.12.2015 issued under endorsement No. SSB/Sel/Secy/2015/17040-43 dated 30.12.2015.

The selection process became subjudice and SSB could not proceed further in view of court directions. Now Hon'ble High Court in SWP No. 2285/2015 titled "Syed Showkat V/S State & Others has ordered as under:-

*"In the meanwhile, respondents are free to make appointments as per the recommendation made by the Services Selection Board, however the same shall be subject to outcome of writ petition. Respondents are further directed to keep four posts vacant till disposal of the writ petition".*
