INTERVIEW NOTIFICATION

1. J&K Services Selection Board invited applications from eligible candidates for following posts of **District cadres in Kashmir Valley** under “**Jammu and Kashmir, Kashmiri Migrants (Special Drive) Recruitment Rules 2009**”, advertised vide Advt Notification No. 06 of 2010 Dated 04-05-2010:-
 - i. **DATA ENTRY OPERATOR** (SOCIAL WELFARE), Item No. 009;
 - ii. **DATA ENTRY OPERATOR** (RELIEF ORGANISATION), Item No. 011; &
 - iii. **DATA ENTRY OPERATOR** (FINANCE), Item No. 014.
2. Eligibility for these posts is: “**10+2 with "O" Level or ITI certificate in computer related activities (One Year) after class 10th.**”
3. Selection Criteria for these posts is:-

i) 10+2	= 20 Points (on prorata basis)
ii) O-level / ITI in Computer related activities	= 30 Points (on prorata basis)
iii) A-level / 3yrs Engg Diploma in Computers / BCA /BIT	= 20 Points (on prorata basis)
iv) B-Level / BE (computers) / MCA/ MSc (Computers / IT)	= 10 Points (on prorata basis)
v) Viva Voce	= 20 points
TOTAL	= 100 points
4. Subsequently, to prepare the interview shortlist of the eligible candidates only, J&K Services Selection Board invited representations from the eligible candidates who had earlier applied for these posts by publishing **Notifications seeking Eligibility Qualification documents** as per qualification eligibility mentioned in para(2) twice, vide its Nos. SSB/Div/J/2010/814-17 dated 15-06-2010 and SSB/Div/J/2010/899-902 dated 25-06-2010 in local leading dailies.
5. Representations have been received from the candidates in response to these **Notifications seeking Eligibility Qualification documents** and after securitizing the same, the candidates shown in Annexure “A” to this notification have been found eligible to call for interview provisionally.
6. Accordingly, a combined provisional list of the candidates called for interview is appended as Annexure “A” to this notification. **Interviews of such candidates will be held on the 9th August, 2010 at Board’s Camp Office, Sehkari Bhawan, Near Bahu Plaza, Jammu from 8:30 AM onwards.**
7. **Since all three Items of Data Entry Operator bear same eligibility and Selection Criteria, Candidate(s) who has / have submitted application forms for more than one posts and called for interview for more than one item of Data Entry Operator will have to appear in the interview only once. Later, J&K Services Selection Board may prepare a combined merit list of the candidates to avoid redundancy / repetitions in the selections for the three Items of Data Entry Operator. Decision of J&K Services Selection Board is this case will be final and binding in accordance with the choice expressed by the candidates at the time of interview.**
8. Only those candidates shall be allowed to appear in the interview, who fully conform to the terms and conditions laid down in the advertisement notices; and have migrated from Kashmir Valley after 1st of the November, 1989 and is registered as such with the Relief Commissioner or has not been so registered on the ground of his being in service of Government in any moving office, or having left the

valley or any other part of the state in pursuit of occupation or vacation or otherwise, and possesses immovable property at the place from where he has migrated but is unable to ordinarily reside there due to the disturbed conditions and includes an internally displaced person; for the purpose of this clause an internally displaced person means a person who had to migrate within the valley from his original place of residence in Kashmir valley for reasons of security and is registered as such with the Relief and Rehabilitation Commissioner Migrants; “ In order to ensure that only bonafide candidates are interviewed by the board, the candidate are required to produce the MIGRATION CERTIFICATE / INTERNALLY DISPLACED CERTIFICATE issued by the Relief and Rehabilitation Commissioner, J&K as per the approved format as a proof”.

9. Board does not recognize distance mode degrees in science subjects, which is in accordance with the DEC / UGC guidelines and the judgment of the Hon'ble Supreme Court. Further, any degree awarded by derecognized deemed universities in distance mode, deemed universities offering degrees / diplomas through their study centres or on franchising basis outside their head quarters i.e., outside the state, shall not be considered. The territorial jurisdiction of their institutions shall be headquarters and in no case outside the state. The distance education council prohibits franchising of study centres. Hence, no weightage shall be accorded to such degrees / diplomas.
10. In the Annexure the candidates have been called for interview, purely on provisional basis subject to satisfaction of all eligibility conditions as notified previously in the respective advertisement notification for the post.
11. Mere figuring of the name in shortlist or provisional list does not entitle a candidate to appear in the interview, as it shall be subject to the scrutiny of all testimonials of the candidates. All academic, educational, technical qualification(s) and experience shall have been successfully acquired / completed by the candidates before the last date of application for the said post, besides satisfaction of all other general eligibility qualification(s) as notified / prescribed in the respective Advertisement Notice for the post. Similarly, additional qualifications / reserved category certificate acquired by the candidate after the last date of receipt of application forms shall not be entertained. In case any deficiency with reference to eligibility etc is proved at the time of interview, the candidate shall not be allowed to appear in the interview, or if any deficiency is found later, the candidate shall not be considered for selection and will be treated as disqualified.
12. Candidates shall have to produce all original certificates / testimonials as well as attested photocopies of the certificates / testimonials including MIGRATION CERTIFICATE in the prescribed format as asked for vide above referred advertisement notification before the selection committee at the time of interview. The candidates who fail to produce such certificates / testimonials may forfeit their candidature. No relaxation will be given to the candidates who fail to produce original as well as attested photocopies of the certificates / testimonials asked for. The copies shall be self attested and attested by Gazetted Officer alongwith his / her seal and signatures.
13. No separate call letters to the candidates for these posts will be despatched.
14. The interview schedule and particulars of the eligible candidates will also be available at the office of the u/s at 1 D/C, Green Belt, Gandhi Nagar, Jammu.
15. Any candidate found guilty of impersonating or submitting fabricated / tampered documents / testimonials or making false, incorrect or suppressing material information shall render him / her liable for criminal prosecution under law and may be debarred permanently or for a specific period for consideration of any or all recruitments made by the Board. Also canvassing / lobbying in any form will entail disqualification of the candidate.
16. No TA / DA shall be paid by the Board for appearing for the interview.
