Subject: - Select list for the post of Jr. Asstt. State/ Divisional/ District Cadre.

Day in and day out, the Board has been receiving representations either by post or through CM's Grievance Cell or seeking information under RTI Act etc. from the candidates regarding change of cadre in the recently issued provisional select lists for the post of Jr. Assistants State/ Divisional/ District Cadre. In this context, it is notified for general information of the public that the Board had conducted written / practical test of the candidates who have applied for the post of Jr. Assistants in response to various advertisement notices issued by the Board from time to time against State/ Divisional/ District Cadre posts. The candidates who qualified the practical test were called for viva voce/ interview cum counseling and at the time of counseling / viva-voce, a choice was obtained from them for exercising the option of State/ Divisional/ District Cadre. Afterwards a panel of qualified candidates was framed in order of merit in both the academic qualification, type test as well as viva voce / counseling. Accordingly, the selection lists for various Indenting/ requisitioning Departments were carved out of the panel of qualified candidates strictly in accordance with their over all merit secured as per practice in vogue and published in the news papers for information and publicity.

During the course of finalization of select lists, the cadre of posts opted by the candidates was taken in to consideration. However, the Board has tried its best to absorb the candidates who have qualified the test/ viva voce in order of merit, in the concerned Cadres/ Departments opted by them, but in the case of those candidates who were not making the grade in the opted Cadres/ Departments due to their less merit, the Board has shown magnanimity in broader interests of the candidates who have, though qualified, but were less in merit and not making the grade in their opted field, in selecting such of them in other Districts where the qualified candidates were not available with a view that Government work may not suffer / hamper due to vacant posts.

As such, by medium of this notice it is once again reiterated that if such of the candidates who are not interested in joining the services in other District/ Cadres other than their District of domicile or where they have actually applied for, he/ she is at liberty to surrender the job by informing this office for paving the way for the candidates who are next in order of merit so that they are considered against these vacancies.
