Whereas Science & Technology Department vide letter No. ST/Adm/G/12/2005 dated.24.01.2006 among others referred 11 posts of Mechanics (3050-4590) and 03 posts of Junior Assistants State Cadre as per the following break-up.

Junior Assistant. OM = 01, SC = 01 & RBA = 01
Total = 03

Whereas these posts were advertised vide Adv. Notification No.01 of 2006 dated.02.02.2006 against State Cadre under item No. 063 & 064 and application forms were received from the candidates/ aspirants.

Whereas the interview/ selection process for the said post was initiated by the Board and selection against one (01) post of Junior Assistant under OM category was recommended to the indenting Department.

Whereas in the mean time the Science & Technology Department vide Govt. Order No. 19-ST of 2011 dated.17.03.2011 issued under endorsement No. ST/ Adm/ J/ 33/ 2009 dated.17.03.2011 have withdrawn the said posts as the Establishment cum Selection Committee of the Department in its decision dated.28.07.2010 decided to wind up the Integrated Rural Energy Programme (IREP).

Whereas the matter was taken up with the indenting Department to route the proposal of withdrawal of the posts through Competent Authority/ GAD

Whereas the General Administration Department vide letter No. GAD (Ser) Genl / 50/ 2010 dated.18.08.2011 have also requested for implementation of the aforementioned Govt. Order No. 19-ST of 2011 dated.17.03.2011.

Now therefore in view of the above position the 11 posts of Mechanics and 02 posts of Junior Assistants are hereby withdrawn and no selection shall be made against these posts by J&K Services Selection Board.
