

ANNEXURE - A

STEPS TO DOWNLOAD RESPONSE SHEET WITH MODEL ANSWER KEY

1. To download the **RESPONSE SHEET WITH MODEL ANSWER KEY**, first visit the official website of JKSSB, i.e. www.jkssb.nic.in.
2. On the homepage, you will get a **NOTICE/LINK** to download Response Sheet with Model Answer Key. Click on that.
3. Then click on the link/button - '**LOGIN**'.
4. Select your post from the drop-down available.
5. Enter log-in credentials, i.e. Username and Password.
6. Username will be your **ROLL NUMBER** & Password will be your DOB in **YYYYMMDD** format.
7. On successful completion of the above step, you will get below two links/buttons:
 - **DOWNLOAD RESPONSE SHEET WITH MODEL ANSWER KEY.**
 - **ADD OBJECTIONS.**
8. On that page, you can download the RESPONSE SHEET with Model Answer Key and 'ADD OBJECTIONS'.
9. To raise objections, click on '**ADD OBJECTION**', select the QUESTION ID from the drop-down against which you want to raise the objection.
10. Select the **NATURE OF THE OBJECTION** from the drop-down.
11. Add your **REMARKS** on the objections raised.
12. Upload a **REFERENCE DOCUMENT** in a .jpg format (file size less than 1 MB).
13. You can raise only **ONE** objection per question.
14. **Rs. 200** will be charged for each objection raised, you can Select & de-select the Objections raised by clicking the checkbox then click on '**CLICK TO PAY ONLINE**' for making Payment.
15. You will be directed to the Payment gateway page, fill in your basic details, and '**MAKE PAYMENT**' using various payment modes.
NOTE: Payment Gateway charges will be applied as extra.
16. After successful Payment, Confirmation Page will be displayed with your Order ID, Keep a Copy of it for future reference. Click on '**EXIT**' and Re-login to download the Print of the Paid Objections.
17. After Re-login, click on '**ADD OBJECTION**', the paid objections will be displayed in **GREEN**, click on the '**PRINT**' option, and take a Print-out of the same for future reference.
