NOTIFICATION

Subject: Cancellation of withheld recommendations of Sh. Shah Omar Mustafa and S. Parvinder Singh for the Post of Field Assistant-III (Agriculture Production Department) Divisional Cadre, Kashmir, advertised vide Notification No. 03 of 2020 dated 01.12.2020, Item No. 023 under PM Package.


Whereas, the J&K Services Selection Board notified the Final Selection List of the candidates for the post of Field Assistant-III (Agriculture Production Department) Divisional Cadre, Kashmir, advertised vide Notification No. 03 of 2020 dated 01.12.2020, item No. 023, under PM Package and recommended the same to the Indenting Department vide letter No. SSB/Secy/Sel/2021/7026-35 dated 14.10.2021; and

Whereas, among the selectees, the recommendations of **Sh. Shah Omar Mustafa**, S/o Bashir Ahmed, figuring at Sr. No. 44 under OM/HCH category and **S. Parvinder Singh**, S/o Sarnpal Singh, Sr. No.45 under OM/HC category, were kept withheld subject to the suitability of sub-handicapped category for the post; and

Whereas, the cu-off date for applying for these posts was 25.01.2021 and the aforesaid candidates have not submitted the Disability Certificate. The JKSSB, vide letter dated 07.06.2022, also sought a clarification from the DMRRR in this regard, but no reply has been received, despite the lapse of considerable time; and

Whereas, the above cases of withheld recommendations were placed in the 147th Board Meeting and the Board decided to cancel these cases as it was observed that the post of Field Assistant-III does not figure in the Government Order No. 59 of 2021 dated 15.04.2021.

Now, therefore, the withheld recommendations of **Sh. Shah Omar Mustafa**, S/o Bashir Ahmed, figuring at Sr. No.44 under OM/HCH category and **S. Parvinder Singh**, S/o Sarnpal Singh, Sr. No.45 under OM/HC category, for the Post of Field Assistant-III (Agriculture Production Department) Divisional Cadre, Kashmir, advertised vide Notification No. 03 of 2020 dated 01.12.2020, Item No.023, under PM Package for Kashmiri Migrants and Non-Migrant Kashmiri Pandits, are hereby Cancelled.
