**Office Order No. 49-SSB of 2023**

**Dated :** 01-02-2023

**Subject: Order passed in Original Application No. 313/2022 dated 19.04.2022 titled *Hilal Ahmad Sofi vs UT of J&K and Ors.***

**Whereas,** the Applicant has approached the Hon'ble Central Administrative Tribunal (CAT) Srinagar Bench, Srinagar through the medium of instant Original Application (OA), wherein, the applicant has prayed for consideration of three representations submitted by him before the Board dated 17.01.2022, 22.03.2022 and 31.03.2022; and

**Whereas,** the Hon'ble CAT disposed of the OA vide order dated 19.04.2022, the operative part of the same is reproduced as under:

***" In view of the limited prayer of the learned counsel for the applicant, we hereby direct the respondents to consider the three representations of the applicant dated 17.01.2022, 22.03.2022 and 31.03.2022 and dispose of the same by passing a reasoned and speaking order within a period of ten days from today. In the meantime, the applicant be allowed to go through the process of document verification as he has been called for the same on***

**Whereas**, the case of the applicant came to be examined by the Board, and during the course of examination, it came to the fore that the applicant has submitted following particulars against advertisement notifications as shown against each:

**Whereas**, Board being conscious of the fact,


that error may occur at the hands of applicants, has provided an opportunity for editing /modification of some of the basic fields to the applicants vide Notice bearing No. SSB/Secy/2021/717-732 dated 28.01.2021; and

Whereas, subsequent to the receipt of valid information of the applicants, the online data gets frozen due to automation, and the same cannot be modified/changed later on to someone's detriment or advantage, as also, there is no scope to entertain offline representations; and

Whereas, Hon'ble Supreme Court of India in Arti Verma case reported in 2014 SCC online ALL 15670 that each candidate reasonably must bear the consequences of his failure to fill up the application for correction when the candidate himself has failed to make a proper disclosure; and

Now, therefore, in view of foregoing, and having regard to the orders passed by the Hon'ble Central Administrative Tribunal Srinagar, the case of the applicant upon examination is considered and found legally not tenable, devoid of any merit, liable to be rejected and is rejected accordingly
