

In response of this office letter a reference has been received from the concerned vide No.F.No.21-40/2020(CPP-II) Dated 18-11-2020, which reveal that Fazil is a UGC specified degree under section 22 of UGC Act, 1956 as per UGC Notification, 2014 notified on specification of degrees, which is available on UGC website and as per Section 22 of UGC Act, 1956, only those universities/institutions are empowered to confer the degrees specified by UGC, which are established or incorporated by or under a central Act, a provincial Act or a State Act or an Institutions specially empowered by and Act of Parliament .Further, it is communicated that the Darul-uloom-Al Madrasat-ul Alia and Govt. Oriental College, Rampur, Uttar Pradesh are not covered under the Section 22 of UGC Act, 1956 and are not empowered to award the degrees specified by UGC and ;


