The candidate has now produced all requisite documents, which were placed in the 268th Board meeting, which decided to release the withheld recommendation of the said candidate selected as Driver in Agriculture Production Department, advertised vide Notification No. 07 of 2020 dated 31.12.2020 /District Cadre.

The documents verification/ scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/ Degree certificates and ascertaining genuineness/ validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/ Appointing authority.

The Selection of the candidate has been made on the basis of Self-declaration/ Certificates submitted by him and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/ certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.

Moreover, in terms of Government Order No. 1003-JK(GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
