Whereas, JKSSB issued a Final Notice, vide No. JKSSB- Scry/13/2023 (7279610) dated 21.05.2025 to these candidates whose recommendation were kept withheld and advised them to submit the requisite documents/ Certificates within 15 days ; and

Whereas, in response to this only one candidate namely Ms. Abida Akhter, S.No. 03, Roll No. 4660228042, in the OM category, has submitted a representation on 26.05.2025 stating that she visited Jamia Millia Islamia University to obtain her experience certificate; and

Whereas, in the meantime, aggrieved to this notice, Ms. Abida Akhter, whose recommendation was kept withheld has approached before Hon'ble CAT and the Hon'ble CAT vide order dated 28.05.2025 has directed the JKSSB to take up matter with Jamia Milla Islamia University for authentication of the experience certificate already submitted by petitioner; and

Whereas, the J&K SSB, has taken up the matter with the Registrar, Jamia Milla Islamia University, New Delhi vide letter dated 13.06.2025, for authentication/genuineness of the eligibility certificate, however the reply for the same is still awaited.

Accordingly, One post against Ms. Abida Akhter on the directions Honb'le CAT was kept reserved and the cancellation of the candidature of above 04 remaining candidates who have failed to produce the requisite documents despite giving final opportunities was placed before the Board in its 309th Board Meeting which decided as under;

"The matter was placed before the board and after perusal of the relevant record, the Board decided to cancel the candidature against four candidates for the post of "Research Assistant (Science and Technology Department)" UT Cadre, Item No. 128 vide advertisement Notification No. 05 of 2020 dated 24.12.2020 and reserve one post on the directions of Hon'ble CAT".

In view of the above, the withheld recommendations of the candidates, as per Annexure-A to this communication for the post of Research Assistant (Science & Technology Department), advertised vide Notification No.05 of 2020 dated.24.12.2020 (Item No.128/ UT Cadre) are hereby cancelled.
