The Election Department vide indent No. 4568/CEO/Estd./SSB/2nd/2775 dated 28.09.2020, among other posts, forwarded the requisition for making direct recruitment to the 23 posts of Data Entry Operator, as per the following break up:

As per the Indent, the qualification prescribed for the posts is (was) "**Graduation with one year diploma in computer software applications or B.Sc. IT /BCA or three years diploma in computer applications /Software applications from an AICTE recognized institution.**"

The Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 23 posts among other posts of Election Department vide Advertisement Notification No. 04 of 2020 dated 16.12.2020 and the cut-off date, i.e., the last date for applying for the aforementioned posts and for determining the eligibility/academic qualification and validity of category certificates and other such documents of the candidates which may be required as per indent was 31.01.2021.

The Board in its 253rd Board Meeting held on 05.01.2024, after deliberations/consideration of aforementioned representations approved the Final Selection List for the 23 posts of Data Entry Operator, advertised under Item No. 098 (UT Cadre, Sub-Department/Appointing Authority-Chief Electoral Officer, J&K) of Election Department, vide Advertisement Notification No. 04 of 2020 dated 16.12.2020 and notified it vide Notification No. JKSSB-Scry/19/2023/03 (E-7325564) dated 15.01.2024, which was forwarded to the indenting department vide communication No. JKSSB-Scry/19/2023/03 (E-7325564) dated 19.01.2024.

The wait list in the instant selection was not forwarded as the practice of drawing up and forwarding the wait lists was discontinued owing to the issuance of S.O. 496 dated 26.09.2023, which omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralisation and Recruitment) Rules, 2010, which provided for the drawing of wait lists and the procedure thereof; and

Whereas, vide S.O. 134 dated 28.02.2024, the earlier omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralisation and Recruitment) Rules, 2010, has again been added to the mentioned rules, to which the effect has been given retrospectively, i.e., from 26.09.2023

(the date of the omission of the said sub-rule) and also vide S.O. 137 dated 28.02.2024, the Board was directed to draw up wait list(s), in respect of those select list(s) which have been issued after 07.09.2023, within a period of six-months, subject to the following conditions; namely:

- (i) That such wait list(s) are drawn within the validity period of the select lists; and
- (ii) That the resultant vacancies on account of non-joining of selected candidates have not been re-advertised.

Consequent upon the receipt of the above-mentioned directions from the General Administration Department, the wait list of 14 candidates for the posts of Data Entry Operator (6=OM, 1=SC, 1=ST, 1=OSC, 1=ALC, 2=RBA, 1=PSP and 1=RBA), advertised under Item No. 098 (UT Cadre, Sub-Department/Appointing Authority- Chief Electoral Officer, J&K) of Election Department, vide Advertisement Notification No. 04 of 2020 dated 16.12.2020, as approved by the Board in its 269th Board Meeting and notified vide notification No. JKSSB-Scry/19/2023/03 (E-7325564) dated 04.06.2024, is enclosed as **Annexure - A** to this communication.

The above Waiting Lists shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Waiting Lists shall also be subject to the outcome of any *inquiry*, involving candidate(s) figuring in this Wait List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

The Selection of the candidates in the wait list has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.
