**Subject: Cancellation of candidature and Debarment of candidate-regarding.**

**Order No: 218-SSB of 2025**  
**Dated: 11-07-2025**

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) conducted OMR Based Examination for the post of Constable (Executive/Armed/IRP/SDRF), Home Department, advertised vide Notification 01 of 2024 dated 16.07.2024 on 01.12.2024; and

Whereas, a candidate namely Aaqib Hussain Baba S/o Abdul Ahad Baba, R/o Manzgam Kulgam, appeared in the said examination under Roll No 950190086 at Government GHSS Yaripora, Kulgam; and

Whereas, concerned Invigilator, Centre Superintendent and Centre Observer reported that after conclusion of the examination the said candidate took away the original OMR sheet along with him, which tantamount to misbehaviour by the candidate under section 65 of J&K Services Selection Board (Conduct of Examinations) Regulations 2022. However, the candidate has returned his OMR sheet immediately after being contacted by the concerned Centre Superintendent/Invigilator; and

Whereas, a show cause notice vide No. JKSSB-COE0Exam (UT)/101/2023-03 (7363646) dated 02.04.2025 was served to the said candidate to explain his position. In response, the said candidate submitted his reply admitting that after culmination of the examination he had taken away the original OMR Sheet outside the Examination Hall inadvertently;

Whereas, the case was placed before the Unfair Means Committee constituted in terms of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022 under part XXX (67), and the committee, after considering the nature of the offence and evidence brought on record, recommended as under: -

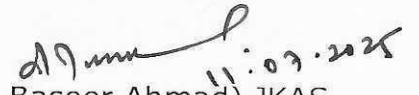
***"The Committee recommends only cancellation of the candidature of the candidate for the said post, with a warning to remain cautious in future".***

Whereas, the recommendations of the Unfair Means Committee were placed before the Board in its 306<sup>th</sup> Meeting held on 12-06-2025 and following decision was taken:

***"The Board perused the report of the Unfair means Committee and accepted its recommendations and decided to cancel the candidature of candidate Aaqib Hussain Baba S/o Abdul Ahad Baba R/o Manzgam Kulgam, 192231, for the post of constable (Executive/Armed/IRP/SDRF) advertised vide notification No. 01 of 2024 dated 16.07.2024 and to debar him for one year".***

Now, therefore, in view of the above and as per section 69 of Jammu and Kashmir Services Selection Board (Conduct of Examinations) Regulations, 2022, the candidature of candidate Aaqib Hussain Baba S/o Abdul Ahad Baba, R/o Manzgam Kulgam, 192231, for the post of Constable (Executive/Armed/IRP/SDRF) advertised vide Notification 01 of 2024 dated 16.07.2024 is hereby cancelled. The candidate is further debarred from all the examinations conducted by the Board for a period of one year from the date i.e. 01.12.2024, on which the said examination was conducted by Board.
