whereas, the J&K Services Selection Board, accordingly, conducted an (OMR) based written examination for these posts on 04.02.2025 and 18.03.2025 and accordingly the result was declared on 16.04.2025 and 27.05.2025; and

whereas, after the publication of Results/Score-sheets, the candidates, falling under the consideration zone, were called for Document Verification on

07.05.2025 and 10.06.2025, followed by supplementary Document Verification on 18.06.2025, 24.06.2025 and 25.06.2025; and

whereas, vide Office Order No 221-SSB of 2025, dated 14.07.2025, a Selection Committee was constituted for preparing the Selection List for these posts of Higher Education Department advertised vide Notification No. 06 of 2020 dated 29.12.2020; and

whereas, the said Selection Committee, upon careful scrutiny of the Indents/advertisements, and procedures thereafter, placed its recommendation before the board in its 331st meeting held on 19.12.2025. The board after due deliberations, approved the notification of the Provisional Selection List prepared by the Selection Committee **(05) Five Posts** of Tabla Assistant, Technical Assistant EduSat, and Edusat Assistant in accordance with the Merit/ Eligibility and preference of the candidates as per the extant rules and the same was notified vide Notification No. JKSSB/Scry/14/2025-03(E-7730337) dated 04.02.2026, seeking objections from the candidates within a period of 10 days from the date of issuance of the notification; and

whereas, pursuant to the above, various representations were received in the Board, which were examined as per the available record/ extant guidelines, for necessary action and based on the objections, the Selection Committee prepared the Final Selection List for **(05) Five Posts** of Tabla Assistant, Technical Assistant EduSat, and Edusat Assistant; and

whereas, the proposal for notifying the Final Selection List, for these **(05) Five posts** of Tabla Assistant, Technical Assistant EduSat, and Edusat Assistant of Higher Education Department advertised vide Notification No. 06 of 2020 dated 29.12.2020, as prepared by the concerned Selection Committee, was placed in the Board in its 350th meeting held on 21.05.2026, which after due deliberation on various aspects related to the instant selection, approved its notification.

Now, therefore, the Final Selection List of the candidates for **(05) Five posts** of Tabla Assistant, Technical Assistant EduSat, and Edusat Assistant of Higher
