Whereas, as per the Indent, the qualification prescribed for the post is as follows: -

“Diploma in Printing Technology from recognized Institute”

Whereas, ARI & Trainings Department vide Letter No. ARI/SP/14/2014 dated: 13.12.2021 clarified the prescribed qualification for the aforementioned post as:-

“Matric with three years Diploma in Printing Technology from AICTE approved Institute”

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 01 post of Printing Down Operator of ARI & Trainings Department vide Advertisement Notification No. 05 of 2020 dated: 24.12.2020; and

Whereas, as per the Notification, the selection to above post was made on the basis of Written Examination only and, accordingly, the JKSSB conducted the OMR Test for the post Printing Down Operator on **15.06.2025** and the result for which was notified vide notification No. JKSSB-COE0EXAM(UT)/23/2025-03 (7699962) dated: 04-08-2025; and

Whereas, on the basis of merit obtained by the candidates, the **Document Verification** for the post of Printing Down Operator was conducted vide Notice No. JKSSB-COE0EXAM(UT)/23/2025-03 (7699962) dated: 24-09-2025 both at Jammu and Srinagar by the DV Committees. Supplementary DV for the candidates was also conducted vide Notice No. JKSSB-COE0EXAM(UT)/23/2025-03 (7699962) dated: 07-10-2025; and

Whereas, the Selection Committee for preparing the selection to the aforementioned post was constituted vide **Order No. 01-SSB of 2026 dated 01.01.2026**; and

Whereas, the provisional selection list for the aforementioned post prepared as per the merit/eligibility of the candidates and having regard to the extant rules /regulations was placed before the Board in its 338th Meeting held on 13.02.2026, which, after deliberations and consideration of the matter, approved its notification which was subsequently notified vide No. JKSSB-Scry/2/2026-06 (E-7839027) Dated: 16-02-2026; and

Whereas, objections (if any), were sought from the candidates through the email address ***usselection-jkssb@jk.gov.in*** within **Ten (10) days** from the date of this Notification; and

Whereas, the proposal for notifying the Final Selection List for the aforesaid post of Printing Down Operator of ARI & Trainings Department advertised vide Advertisement Notification No. 05 of 2020 dated: 24.12.2020 under Item No. 174, as prepared by the concerned Selection Committee, was placed in the Board in its 347th meeting held on 23.04.2026, which after due consideration and deliberation on various aspects attendant to the selection, approved its notification.
