The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the above candidate whose case was reserved and now has been filled/released by the Selection Agency, shall submit her Personal Verification Roll (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego her right to appointment forthwith.
