Whereas, the Jal Shakti Department vide indent No. 28166 JSD-NGJ02/2/2021 dated 09.02.2023, among other posts, forwarded the requisition for making direct recruitment to the 105 posts of Draftsman (Civil), as per the following break up:



Whereas, as per the Indent, the qualification prescribed for the posts is (was) as follows:

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 105 posts among other posts of Jal Shakti Department vide Advertisement Notification No. 01 of 2023 dated 11.04.2023; and

Whereas, as per the Notification, the selection to these posts was to be made on the basis of Written Examination only and, accordingly, the JKSSB conducted the OMR based test for these posts on 24.09.2023 and, thereafter the JKSSB notified result of candidates for the said posts vide Notification No. JKSSB/COE0EXAM(UT)/64/2023-03(7263602) dated 08.10.2023 and on the basis of merit obtained by the candidates, the Document Verification was conducted vide Document verification Notice No. JKSSB/COE0EXAM(UT)/64/2023-03(7263602) dated 12.10.2023, w.e.f. 16.10.2023 to

19.10.2023 , both at Jammu and Srinagar by the DV Committees constituted vide Order No. 224-SSB of 2023 dated 13.10.2023 followed by the Supplementary DV, conducted vide Notification No. JKSSB/COE0EXAM(UT)/64/2023-03(7263602) dated 20.10.2023; and

Whereas, the Selection Committee for preparing the selection to the aforementioned posts was constituted vide Order No.228-SSB of 2023 dated 13.10.2023; and

Whereas, the Final Selection List for the above mentioned 105 posts, was approved by the Board in its 253rd Board Meeting and the recommendations were forwarded to the Indenting Department vide communication No. JKSSB-Scry/24/2023-03(E-7336923) dated 02.02.2024; and

Whereas, in the said forwarded list 3 slots were kept reserved under EWS category for want of valid within date EWS category certificates as per UT format. Whereas, **one slot** was kept reserved at **S. No. 4**, under **EWS** category, for **Item No. 5, Draftsman Civil, Divisional Cadre, Jammu** and **two slots** were kept reserved at **S. No. 5 and 6**, under **EWS** category, for **Item No. 6, Draftsman Civil, Divisional Cadre, Kashmir**; and

Whereas, vide Notice no. JKSSB-Scry/24/2023-03(E-7336923) dated 02.02.2024, the following three candidates, falling in the consideration zone were advised to submit the requisite documents/certificates in support of the deficiency as indicated against each, enabling the Board to decide their candidature:

Whereas, after the expiry of the notice period only one candidate figuring at **S. No. 3**, in the table above, namely **Shahid Iqbal**, submitted the requisite documents/clarifications in support of his deficiency, which were examined and found adequate, the other two candidates namely **Karan Bali** and **Rajat Sharma**, figuring at **S. No. 1 and 2**, respectively, in the table above, after unsatisfactory response to the first notice were put to a Final Notice vide Notice no. JKSSB-Scry/24/2023-03(E-7336923) dated 03.07.2024; and

Whereas, the responses/clarification/documents furnished by the candidates namely **Karan Bali** and **Rajat Sharma**, figuring at **S. No. 1 and 2**, respectively, in the table above in the table above, in response to both the notices, were discussed at length in the Board in its 283rd Board Meeting held on 17.09.2024, which after deliberation upon the data placed before it, taking note of the fact that sufficient time and two Notices had been served to the said 2 candidates falling in the consideration zone under EWS category and none of the above-mentioned candidates was able to produce certificates/clarifications as were required by the board to consider their candidature, decided to cancel their candidature and that the candidates, figuring next in merit, shall be examined for their consideration for the selection against the posts reserved under EWS category.

Now, therefore, it is hereby notified that:

- (i) The candidates figuring in **Annexure-A** shall figure against the reserved posts (at the serial as indicated against each) in the Final Selection List notified for the posts of **Draftsman Civil**, Jal Shakti Department, Advertisement Notification No. 01 of 2023 dated 11.04.2023, **Item No. 05**, Divisional Cadre Jammu and **Item No. 06**, Divisional Cadre Kashmir.
- (ii) The above selection of the candidates shall be subject to outcome of the OAs/Writ Petition(s), if any, pending adjudication before any Competent Court of law and shall also be subject to the outcome of any pending *enquiry*, involving candidate(s).
- (iii) The Selection of the candidates has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage.
