Whereas, the Jammu and Kashmir Services Selection Board, vide Indent No. Edu/Tech/Gen/16/2019 dated 23.12.2020, received (06) Posts of Computer Instructor/Operator, Audio Visual Mechanic, Kitabat Instructor and Junior Engineer in Skill Development Department with Pay Level-6 & 6D, advertised vide Notification No. 07 of 2020 dated 31.12.2020 under Item Nos. 309,319, 329 & 334 as per the following category-wise break up:

Audio Visual Mechanic	03 years diploma with not less than 65% marks in Electronics & Communication from a recognized Institute/Board.
Kitabat Instructor	Matric having passed with 2 years Urdu Calligraphy examination from a recognized Institution/Board with 5 years practical experience.
Junior Engineer	Degree in Electrical/Mechanical/ Civil/Computer/Electronics and Communication from any recognized University with minimum 50% marks.

whereas, the JKSSB, accordingly conducted an (OMR) based written examinations for these posts on 16.02.2025, 02.03.2025, 09.03.2025 and



18.03.2025 and accordingly the result was declared on 14.05.2025, 20.05.2025, 24.05.2025 and 27.05.2025; and

whereas, after the publication of Results/Score-sheets for the above mentioned posts, the candidates falling under the consideration zone, were called for Document Verification on 06.05.2025, 04.06.2025, 09.06.2025 and 10.06.2025 followed by supplementary Document Verification w.e.f 20.06.2025 to 25.06.2025; and

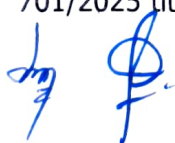
whereas, vide Office Order No. 221-SSB of 2025 dated 14.07.2025, among other committees, a selection committee was constituted for preparing the Selection List for these 06 posts of Skill Development Department, advertised vide Notification No. 07 of 2020 dated 31.12.2020 under Item Nos. 309, 319, 329 & 334; and

whereas, the said Selection Committee, upon careful scrutiny of the Indents/ advertisements, prepared the Provisional Selection List for these **06 posts** in accordance with the Merit/ Eligibility and preference of the candidates as per the extant rules and same was placed in the board in its 331st Board Meeting held on 19.12.2025, which after due deliberations and consideration of the matter, approved its notification; and

whereas, the Provisional Selection List for the aforesaid 06 posts of Computer Instructor/Operator, Audio Visual Mechanic, Kitabat Instructor and Junior Engineer was accordingly, notified vide No. JKSSB-Scry/15/2025-03 (E-7730610) dated 09.01.2026, seeking objections from the candidates within a period of 10 days from the date of issuance of the notification; and

whereas, pursuant to the above, various representations were received in the Board, pertaining broadly to submission of documents w.r.t. withheld cases, correction in particulars etc., which were examined as per the available record/ extant guidelines, for necessary action; and

whereas, in compliance to orders of the Hon'ble CAT in O.A No. 701/2025 titled Sajad Ahmad Payer Vs UT of J&K and Ors, **(01) one post** of Kitabat



Instructor (RBA) needs to be kept reserved pending further directions; and

whereas, the proposal for notifying the Final Selection List, for the aforesaid **06 posts** of Computer Instructor/Operator, Audio Visual Mechanic, Kitabat Instructor (*01 RBA post to be reserved as per CAT order*) and Junior Engineer of Skill Development Department, advertised vide Notification No. 07 of 2020 dated 31.12.2020, under Item Nos. 309, 319, 329 & 334, as prepared by the concerned Selection Committee, was placed in the Board in its 338th meeting held on 13.02.2026, which after due deliberation on various aspects related to the instant selection, approved its notification.

Now, therefore, the Final Selection List of the candidates for **06 posts** of Computer Instructor/Operator, Audio Visual Mechanic, Kitabat Instructor (*01 RBA post reserved as per CAT order*) and Junior Engineer of Skill Development Department, advertised vide Notification No. 07 of 2020 dated 31.12.2020, under Item Nos. 309, 319, 329 & 334, is hereby notified as per "**Annexure-A**" to this Notification. It is further notified that:

The selection of the candidate has been made on the basis of Self-declaration/ certificates submitted by him/ her and if at any stage, it comes to light that he/ she has submitted false information or has secured selection on the basis of fake or invalid documents/ certificates, the selection shall be liable to cancellation at any stage.
