Whereas, the JKSSB vide Notification No. JKSSB-COE0EXAM/UT/10/2023-04 (7055504) Dated. 03.01.2025, issued an Advance Notice for holding the OMR based written Examination for these posts to be held on **27.02.2025** and after holding the exams, the Result/Score-sheet of the candidates was notified vide notification No. JKSSB-COE0EXAM(UT)/9/2025-06 (7650128) dated: 05.05.2025; and

Whereas, the schedule of the Documents Verification (DV) of the candidates falling under the consideration zone were notified vide notification No. JKSSB-COE0EXAM(UT)/9/2025-06 (7650128) dated: 20-05-2025, followed by Supplementary Document Verification (DV) vide No. JKSSB- COE0EXAM(UT)/9/2025-06 (7650128) dated: 13.06.2025; and

Whereas, the Board vide office **Order No. 221-SSB of 2025 dated 14.07.2025** constituted a Selection Committee, for preparing the Selection List for the posts of **"Panchayat Secretary"** under various Items. The Selection Committee so constituted

prepared the Provisional Selection List in accordance with the Merit/Eligibility of the candidates and on the basis of principle of merit-cum-preference and the same was placed before the Board in its 312th Board Meeting held on 05.08.2025, which after deliberations and having regard to all the aspects of the selection, approved its notification and the same was notified vide No. JKSSB-Scry/26/2025-03(E-7733324) Dated. 24.09.2025, for seeking objections from the candidates; and

Whereas, after examination of the representations received to the Provisional Selection List, the Board, in its 334th Board Meeting held on 02.01.2026, deliberated and approved the proposal for notifying the Final Selection List for the above said post.
