Whereas, the receipt of Indent/requisition from the Department of Culture, vide Indent No. No. LD(Estt)2019/51 dated 05.10.2020 followed by LD(SL) 2015/14-Adv.Gen dated 08.12.2020, wherein the department forwarded the requisition for making direct recruitment to the 04 posts of **Sub-Editor**, Department of Law Justice and Parliamentary Affairs, under Item No. 156 Level-6B (35600-112800 as per following break up:

The qualification for selection against the post, as per the Indent/Advt., is/was as under:

“Graduate from any recognized University with Urdu as one of the subject in Graduation and experience in Calligraphy with Diploma in Urdu Software (In Page).”

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB), advertised the aforesaid 04 posts as per the category-wise break up given herein above, vide Notification No. 05 of 2020 dated 24-12-2020, under various Item No. 156, for seeking applications from the eligible candidates; and

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) vide Notification No. JKSSB-COEEXAM(UT)/10/2022-04 (7055504) dated 03.05.2024, issued an Advance Notice for holding the OMR based written examination for Graduate Level Posts which was held on **02.06.2024**. After holding the examination, the objections were examined and the Revised/Final Answer Key in respect of written examination held for the said posts was notified vide No. JKSSB/COEEXAM(UT)/21/2024-06 (7483967) dated 12.06.2024; and

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) based on the performance of the candidates notified the Result/Score-sheet vide Notification No. JKSSB/COEEXAM(UT)/21/2024-06 (7483967) dated: 12-06-2024; and

Whereas, the schedule of the Documents Verification (DV) of the candidates falling under the consideration zone was notified vide notification No. JKSSB/COEEXAM(UT)/21/2024-06 (7483967) dated: 19.10.2024, followed by



Supplementary Document Verification (DV) vide No. JKSSB/COEOEXAM(UT)/21/2024-06 (7483967) dated: 13.12.2024; and

Whereas, the Board constituted a Selection Committee vide office Order No. 372-SSB of 2024 dated 05.11.2024, for preparing the Selection List for various Graduate Level Posts. The Selection Committee so constituted prepared the Provisional Selection List in accordance with the Merit/Eligibility of the candidates and on the basis of principle of merit-cum-preference and the same was placed before the Board at its 305th meeting held on 22.05.2024, which after deliberations and having regard to various aspects of the selection, approved its notification and the same was notified vide No. JKSSB-Scry/4/2025-06 (E-7637857) Dated: 11.06.2025, seeking objections from the candidates; and

Whereas, after examination of the representations received to the Provisional Selection List, the Board, in its 334th Board Meeting held on 02.01.2026, deliberated and approved the proposal of the selection committee for notifying the Final Selection List for the above said post which has been notified vide Notification No. 05-Selection of 2026 Dated: 11th of February, 2026, under endorsement No. JKSSB-Scry/4/2025-06(E-7637857) Dated: 11.01.2026.

However, vide Office Order No. 47-SSB of 2026 Dated. 12.02.2026 the Final Selection list for the post of Sub-Editor (Urdu), Department of Law, Justice and Parliamentary Affairs, advertised vide Notification No. 05 of 2020 dated 24.12.2020, under Item No. 156, the selection to the posts of Sub-Editor (Urdu) is hereby kept in abeyance till further orders; and

Whereas, the Board has received the order dated 07.04.2026 from the Hon'ble Central Administrative Tribunal (CAT) in M.A. 176/2026 which is reproduced as under:

"The submissions of learned counsel for the parties appear to be plausible. Accordingly, order dated 22.07.2025 is modified to the extent that one post shall be kept reserved under RBA category for the applicant till the next date of hearing. Further, parties are directed to advance their arguments on the next date;" and

Whereas, in pursuance to the above order, the matter was deliberated in 348th Board meeting wherein Board approved the notification of the Final Selection List for the post(s) of **Sub-Editor**, Department of Law Justice and Parliamentary Affairs, UT Cadre, under Item No. 156.

Now, after taking into consideration all the aforementioned factors, the Final Selection List for the posts of **Sub-Editor**, Department of Law Justice and Parliamentary Affairs, UT Cadre, under Item No. 156, advertised vide Notification No. 05 of 2020 dated 24.12.2020, is hereby notified as per "**Annexure-A**" to this notification. It is further notified that:

- i. The Final Selection List shall be subject to the outcome of OAs/writ petition(s), if any, pending adjudication before any competent court of law.
- ii. The list shall also be subject to the outcome of such inquiry, involving any candidate(s), as figuring in this list.
- iii. The formal recommendations to the concerned Indenting Department shall be made separately.



- iv. The candidates(s), whose recommendations are kept withheld, shall submit the requisite documents/Certificates within a period of one month.
- v. The Selection of the candidates has been made on the basis of self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage.
- vi. This being a combined selection, the Waiting List shall be notified and forwarded only on the request of the Indenting Department, against the non-joining candidates, if any.
