NOTIFICATION

Subject: Final Selection List-cum-Allocation of Cadres/Departments for remaining Class-IV posts- *cancellation of recommendation thereof.*

Whereas, the Final Selection for 3422 Class-IV posts, under Phase-II, in District/ Divisional/Union Territory Cadres, advertised vide Notification No. 01 of 2020 dated 04.06.2020, was notified by the Board vide Notification No. SSB/Secy/Sel/Class-IV/2021/6202-09 dated 06.10.2022 and forwarded to the General Administration Department vide No. SSB/Secy/Sel/Class-IV/2021/6273-78 dated 18.10.2022, for further course of action ; and

Whereas, among the selectees, Mr. Sajid Ali Zargar S/o Mohd Ishaq Zargar, R/o Kishtwar, was selected as Class-IV, having Roll No. 161224403275, under EWS category, District Cadre Kishtwar in the School Education Department, advertised vide Notification No. 01 of 2020 dated 26.06.2020; and

Whereas, the School Education Department vide letter No. DSEJ/NG/NT-23/C. No. 7322189/6610-11 dated 19.03.2024, has forwarded a variation case in DoB and clarification regarding EWS certificate of Mr. Sajid Ali Zargar S/o Mohd Ishaq Zargar, R/o Kishtwar, under EWS category, District Cadre Kishtwar selected as Class IV, Roll No. 161224403275 in the School Education Department advertised vide Notification No. 01 of 2020 dated 26.06.2020; and

Whereas, it is observed that the EWS certificate issued by the Tehsildar Kishtwar in favour of Mr. Sajid Ali Zargar stand expired on 19.06.2020. Furthermore, the Advertisement Notification No. 01 of 2020 was issued on 26.06.2020, which indicates that the candidate -Mr. Sajid Ali Zargar, did not possess a valid EWS category certificate as on the date of issuance of the said advertisement notification.; and

Whereas, the instant matter was placed before the Board, and the Board in its 301st Meeting decided as under:

"The matter was discussed/deliberated in the Board and it was decided that the candidate viz., Mr. Sajid Ali Zargar S/o Mohd Ishaq Zargar, R/o Kishtwar, is not in possession of a valid within date EWS Certificate as on the cut-off date notified for these Class-IV posts, advertised vide Notification No. 01 of 2020 dated 26.06.2020. Thus, the candidate was not eligible for consideration under EWS category and the issue has not been pointed out by the concerned Document Verification Committee (possibly on account of the selection being very large) at the relevant point of time. On the intimation of School Education Department, the Board decided that the recommendation of Mr. Sajid Ali Zargar S/o Mohd Ishaq Zargar, R/o Kishtwar, for the post of Class IV, Roll No. 161224403275

under EWS Category, District Cadre, Kishtwar, in the School Education Department, advertised vide Notification No. 01 of 2020 dated 26.06.2020 shall be withdrawn after affording him a final opportunity of being heard by way of a Notice"

Whereas, the J&K Services Selection Board served a final opportunity notice dated 17.04.2025, advising the above mentioned candidate to explain his position within a period of **07 days** from the date of issuance of the Notice; and

Whereas, Mr. Sajid Ali Zargar S/o Mohd Ishaq Zargar, R/o Kishtwar, failed to produce a valid and within-date EWS certificate despite the lapse of considerable time.

Now, therefore, the recommendation of Mr. Sajid Ali Zargar S/o Mohd Ishaq Zargar, R/o Kishtwar, for the post of Class IV, having Roll No. 161224403275 under EWS Category, District Cadre, Kishtwar, in the School Education Department, advertised vide Notification No. 01 of 2020 dated 26.06.2020 is hereby **cancelled/withdrawn ab-initio**.
