Subsequently, these candidates, submitted the documents/ certificates in support of their withheld recommendations and the same were placed before the Board, in its 278th Meeting, which decided to release their withheld recommendations.

Accordingly, the undersigned is directed to convey the above decision of the Board and release the withheld recommendation of the candidates for these posts of Junior Engineer (Civil), Public Works (R&B) Department, advertised vide Notification No. 06 of 2022 dated 11.11.2022, with the request to proceed in the matter accordingly.



The above shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Selection List shall also be subject to the outcome of any Inquiry, involving candidate(s) figuring in this Selection List.

The document verification/ scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/ Degree certificates and ascertaining genuineness/ validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/ Appointing authority.

The Selection of the candidates has been made on the basis of Self declaration/ Certificates submitted by them, and if at any stage, it comes to the light that, any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, such selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate(s) may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK (GAD) of 2021 dated 27.09.2021, the candidates, whose recommendations are released by the Selection Agency, shall submit their Personal Verification Roll (PVR) before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
