Whereas, the Department of Forest, Ecology and Environment, vide Indent No. FST/Ser/49/2020 dated 22.03.2020, forwarded the requisition for making direct recruitment to the **05 posts** of Junior Environmental Engineer, Level-6D (35800-113200), with the following category-wise break-up:

Whereas, the requisite qualification for selection against these posts, as per the Indent, is as under:

***"Bachelor's Degree in Civil/Mechanical/Chemical/Environmental Engineering of AMIE Section (A&B) India or 3 Years diploma from Indian University/Institute in Civil/Mechanical/ Chemical/Electrical and Environmental Engineering discipline with at least 60% marks in aggregate."***

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB), advertised the aforesaid 05 posts as per the category-wise break up given herein above, vide Notification No. 03 of 2021 dated 04.06.2021 under Item No. 557, for seeking applications from the eligible candidates; and

Whereas, the JKSSB, vide Notification No. JKSSB-COE0EXAM(UT)/88/2023-03-SSB dated 30.10.2023, issued an Advance Notice for holding the OMR based Written Examination for these posts on 05.11.2023 and after holding the exams, the Result/Score-sheet of the candidates was notified vide No. JKSSB/COE0EXAM(UT)/88/2023-03 (7314392) dated 19.11.2023; and

Whereas, the schedule of the Documents Verification (DV) of the candidates falling under the consideration zone were notified vide notification No. JKSSB/COE0EXAM(UT)/88/2023-03 (7314392) dated 24.11.2023, followed by Supplementary Document Verification (DV) vide No. JKSSB-COE0EXAM(UT)/85/2023-03(CC-7309695) dated 23.12.2023; and

Whereas, this was followed by the constitution of the Selection Committee vide Office No. 03-SSB of 2024 dated 03.01.2024 for preparing the Selection List for the said posts. The Selection Committee so constituted prepared the Provisional Selection List in accordance with the Merit/Eligibility of the candidates and as per the extant rules; and




Whereas, the Provisional Selection List, as prepared by the aforesaid Selection Committee, for these posts of Junior Environmental Engineer, UT Cadre, was approved by the Board in its 253<sup>rd</sup> meeting held on 05.01.2024 and subsequently, notified vide No. JKSSB-SD0SECY(JMU)/4/2024-03(E-7381434) dated 10.01.2024, seeking objections from the candidates; and

Whereas, the Board, in its 256<sup>th</sup> Meeting held on 23.01.2024, deliberated and approved the proposal for notifying the Final Selection List for the aforementioned posts of Junior Environmental Engineer, Department of Forest, Ecology and Environment.

Now, therefore, after taking into consideration all the aforementioned factors, the Final Selection List of the candidates for five (5) posts of Junior Environmental Engineer, Department of Forest, Ecology and Environment, UT Cadre, advertised vide Notification No. 03 of 2021 dated 04.06.2021, under Item No. 557, is hereby notified as per **Annexure-A** to this notification. It is further notified that:

- (1) The above Final Selection List shall be subject to outcome of the OAs/Writ Petition(s), if any, pending adjudication before any Competent Court of law.
- (2) The List shall also be subject to the outcome of such *enquiry*, involving any candidate(s), as figuring in this List.
- (3) The formal recommendations to the concerned Indenting Department shall be forwarded separately.
- (4) The Selection of the candidates has been made on the basis of the Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that they have submitted false information or have secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage.
