Whereas, as per the Indent, the qualification prescribed for the posts is as follows:

1.	187	Assistant PTI	Div. Jammu	B.P.E (three years Course) or Graduate with B.P.Ed from a recognized University preference shall be given to those who have outstanding career and have participated in the recognized events at the National / International level.

Whereas, the Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid post of Higher Education Department among other posts vide Advertisement Notification No. 06 of 2020 dated 29.12.2020 and the cut-off date, i.e., the last date for applying for the aforementioned posts and for determining the eligibility/academic qualification and validity of category certificates and other such documents of the candidates which may be required as per Indent was 27.02.2021; and



Whereas, the Jammu & Kashmir Services Selection Board (JKSSB) conducted written examination for the above mentioned post on 16.02.2025 ; and

Whereas, the JKSSB, vide Notification No. JKSSB-COE0EXAM(UT)/9/2025-06(7650128) dated 24/04/2025, issued the result/Score Sheet of the candidates who appeared in the OMR Based Written Examination held on 16.02.2025 for the said post. Thereafter, schedule for Documents Verification (D.V.) of the Candidates falling under the consideration zone was notified vide Notification No. JKSSB-COE0EXAM(UT)/9/2025-06(7650128) dated: 24.12.2025 and Supplementary Document Verification (D.V.) vide No. JKSSB-COE0EXAM(UT)/9/2025-06(7650128) dated 30.12.2025; and

Whereas, the Selection Committee for preparing the selection to the aforementioned posts was constituted vide Order No. 68-SSB of 2026 dated 23.02.2026 and the selection stands framed by the Selection committee strictly in accordance with the indent received from the Indenting Department. It is pertinent to mention that the horizontal reservation in this particular selection could not be implemented due to less number of posts in the items for the block as required for ESM and PwDs; and

Whereas, the provisional selection list for the aforementioned posts, prepared as per the merit/eligibility of the candidates and having regard to the extant rules /regulations was approved by the Board in its 347th Meeting held on 23.04.2026 and subsequently notified vide Notification No. JKSSB-Scry/07/2026-AO(E-7861331) dated 29.04.2026, seeking objections from the candidates; and

Whereas, after examination of the representations received regarding the Provisional Selection List, the Board, in its 350th Board Meeting held on 21.05.2026, deliberated and approved the proposal for notifying the Final Selection List for the above said posts.

Now, therefore, the Final Selection List of the candidates for the aforementioned Post of Assistant PTI, Higher Education Department – Advertisement No. 06 of 2020, Item No. 187 (Division Jammu) is hereby notified as **Annexure-A** to this Notification. It is further notified that:

- (1) The above Final Selection List shall be subject to the outcome of OAs/Writ Petition(s), if any, pending adjudication before any Competent Court of law.
- (2) The List shall also be subject to the outcome of such inquiry, involving any candidate(s), as figuring in this List.
- (3) The formal recommendations to the concerned Indenting Department shall be made separately.



- (4) The Selection of the candidates has been made on the basis of *Self-declaration/Certificates* submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage.
