Kindly refer to the subject cited above, wherein the Department of Disaster Management, Relief, Rehabilitation and Reconstruction (DMRRR), vide indent No. DMRRR-MR/86/2021 dated 23-02-2022 and No. DMRRR-MR/86/2021 dated 06.09.2022, among other posts, forwarded the requisition for making direct recruitment to the 30 posts under various items as per the following break up:

The cut-off date i.e. the last date for applying for these posts and determining the eligibility/academic qualification and category certificates of the candidates, was **19.10.2022**.

The Jammu and Kashmir Services Selection Board (JKSSB) advertised the aforesaid 30 posts among other posts of Department of Disaster Management, Relief, Rehabilitation and Reconstruction (DMRRR) vide Advertisement Notification No. 05 of 2021 dated 09.09.2022.

The Provisional Selection List and Final Selection List for the aforementioned posts, were notified vide Notification No. SSB/Secy/Sel/2023/951-63 dated 20.10.2023 (approved in the 241<sup>st</sup> Board Meeting) and vide Notification No. JKSSB/Sel/Secy/2023/1007-1019 dated 02.11.2023 (approved in the 242<sup>nd</sup> Board Meeting), respectively and the recommendations to the indenting department were forwarded vide communication No. JKSSB-Scry/8/2023-03(E-7263656) dated 08.11.2023.

The wait list in the instant selection was not forwarded as the practice of drawing up and forwarding the wait lists was discontinued owing to the issuance of S.O. 496 dated 26.09.2023, which omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralization and Recruitment) Rules, 2010, which provided for the drawing of wait lists and the procedure thereof.

Vide S.O. 134 dated 28.02.2024, the earlier omitted sub rule (7) of rule 14 of the Jammu and Kashmir Civil Services (Decentralisation and Recruitment) Rules, 2010, has again been added to the mentioned rules, to which the effect has been given retrospectively, i.e., from 26.09.2023 (the date of the omission of the said sub-rule) and also vide S.O. 137 dated 28.02.2024, the Board was directed to draw up wait list(s), in respect of those select list(s) which have been issued after 07.09.2023, within a period of six-months, subject to the following conditions; namely:

- (i) That such wait list(s) are drawn within the validity period of the select lists; and
- (ii) That the resultant vacancies on account of non-joining of selected candidates have not been re-advertised.

Also, as no suitable candidates are available in the entire merit list for the posts under Item No. 194 (Motor Vehicle Traffic Assistant, Divisional Cadre, Kashmir, Sub-Department/Appointing

Authority - Transport Department) and Item No. 199 (Junior Librarian, District Cadre, Shopian, Sub-Department/Appointing Authority - School Education Department) & Item No. 200 (Junior Librarian, District Cadre, Kulgam, Sub-Department/Appointing Authority - School Education Department) in the instant selection, the waiting lists for aforesaid three items (194, 199 & 200) cannot be prepared.

Consequent upon the receipt of the above-mentioned directions from the General Administration Department, the wait list of 01 candidate (OM=1) for the post under Item No. 195 (**Assistant Law Officer**, Divisional Cadre, Kashmir, Sub-Department/Appointing Authority – Department of Law, Justice and PA) and the wait list of 09 candidates (OM=8, RBA=1) under Item No. 198 (**Motor Vehicle Inspector**, Divisional Cadre, Kashmir, Sub-Department/Appointing Authority – Transport Department, of the Department of Disaster Management, Relief, Rehabilitation and Reconstruction (DMRRR), pursuant to Advertisement No. 05 of 2022 dated 09.09.2022, was approved by the Board in its 269<sup>th</sup> Board Meeting and notified vide Notification No. JKSSB-Scry/8/2023-03(E-7263656) dated 04.06.2024. The wait list so notified is enclosed as **Annexure - A** to this communication.

The above Waiting List shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Waiting Lists shall also be subject to the outcome of any *inquiry*, involving candidate(s) figuring in this Wait List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing authority.

The Selection of the candidates in the wait list has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of fake documents/certificates, the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.
