As per the Indent, the qualification prescribed for the posts was (is) as under:

"Graduate from recognized University having 65 words per minute speed in short hand and 35 words per minute speed in typing"

The J&K Services Selection Board, conducted the Type Test and Short Hand Test for these posts for which the result was declared on 19.10.2024 & 25.10.2024 and accordingly, the Written Examination (OMR based) of the successful candidates for these posts of Junior Stenographer was conducted on 31.12.2024. Based on the performance of the candidates in it, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/56/2023-03 (7245277) dated 17.03.2025, published the Result/Score-sheet of the candidates.

After the publication of Result/Score-sheet, the candidates, falling under the consideration zone, were called for Document Verification vide Notification No. JKSSB-COE0EXAM(UT)/56/2023-03 (7245277) dated 02.04.2025, at both Jammu & Srinagar office on 11.04.2025, followed by supplementary DV on 25.04.2025.

The Final Selection List for these posts of Junior Stenographer, as prepared by the concerned Selection Committee, was approved by the Board in its 310th Board Meeting held on 24.07.2025, and subsequently notified vide Notification No. 07-Selection of 2025 dated 30.07.2025, under endorsement No. JKSSB-Scry/11/2025-06 (E-7704003) dated 30.07.2025.

Accordingly, the undersigned is directed to forward herewith the selection list of **03 posts** of Junior Stenographer, Agriculture Production Department, UT/Divisional Cadre, advertised vide Notification No. 05 of 2021 dated 22.09.2021 under various Item Nos as per **Annexure "A"** to this communication.

The Selection of the candidates has been made on the basis of Self-declaration/ Certificates submitted by them and if at any stage, it comes to the notice that any candidate(s) has submitted false information or has secured selection on the basis of fake or invalid document/ certificates, the selection shall be liable to cancellation at any stage and appropriate Criminal proceedings against such candidate/s may kindly be initiated.

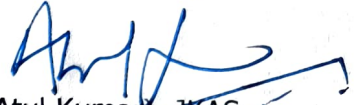

days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
