Consequent upon the receipt of requisition from the Animal/ Sheep Husbandry & Fisheries Department, vide Indent No. ASH/Coord/24/2014 dated 29.09.2020, the Jammu and Kashmir Services Selection Board, among other posts, advertised **01 post** of Junior Stenographer, vide Notification No. 04 of 2021 dated 17.07.2021, under Item No. 636 with the breakup of post as under:

As per the Indent, the qualification prescribed for the post was (is) as under:

"Graduate from recognized University having 65 words per minute speed in short hand and 35 words per minute speed in typing"

The J&K Services Selection Board, conducted the Type Test and Short Hand Test for the post of Junior Stenographer for which the result was declared on 19.10.2024 & 25.10.2025, and accordingly, the Written Examination (OMR based) of the successful candidates for the post of Junior Stenographer was conducted on 31.12.2024. Based on the performance of the candidates in it, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/56/2023-03(7245277) dated 17.03.2025 published the Result/Score-sheet of the candidates.

Whereas, after the publication of Result/Score-sheet, the candidates, falling under the consideration zone, were called for Document Verification both at Jammu and





Srinagar on 11.04.2025, followed by supplementary Document Verification on 25.04.2025.

The Final Selection List for the post of Junior Stenographer, as prepared by the concerned Selection Committee, was approved by the Board in its 310th Board Meeting held on 24.07.2025, and subsequently notified vide Notification No. 07-Selection of 2025 dated 30.07.2025, under endorsement No. JKSSB-Scry/11/2025-06 (E-7704003) dated 30.07.2025.

Accordingly, the undersigned is directed to forward herewith the selection list of **01 post** of Junior Stenographer Animal/Sheep Husbandry & Fisheries Department, Division Cadre, Kashmir advertised vide Notification No. 04 of 2021 dated 17.07. 2021 under Item No. 636 as per **Annexure "A"** to this communication.

The above Selection list shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction related to the selection. The Selection List shall also be subject to the outcome of any *inquiry*, if any, involving candidate(s), figuring in this Selection List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity etc. or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing Authority.

The Selection of the candidate has been made on the basis of self-declaration/ Certificates submitted by him and if at any stage, it comes to the notice that a candidate has submitted false information or has secured selection on the basis of fake or invalid document/ certificates, the selection shall be liable to cancellation at any stage and appropriate Criminal proceedings against such candidate may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates whose recommendation(s) are released by the Selection Agency shall submit their Personal Verification Rolls (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
