As per the Indent, the qualification prescribed for the posts was (is) as under:

"Graduate on the basis of test in stenography and type writing with minimum speed of 65 and 25 words per minute respectively"

The J&K Services Selection Board, conducted the type test and Short Hand Test for these posts for which the result was declared on 19.10.2024 & 25.10.2024, and accordingly, the Written Examination (OMR based) of the successful candidates for the posts of Steno Typist was conducted on 31.12.2024. Based on the performance of the candidates in it, the Board, vide Notification No. JKSSB-COE0EXAM(UT)/56/2023-03(7245177) dated 17.03.2025 published the Result/Score-sheet of the candidates.

Whereas, after the publication of Result/Score-sheet, the candidates, falling under the consideration zone, were called for Document Verification both at Jammu and Srinagar on 16.04.2025, followed by supplementary Document Verification on 25.04.2025.

The Final Selection List for the post of Steno Typist, as prepared by the concerned Selection Committee, was approved by the Board in its 310th Board Meeting held on 24.07.2025, and subsequently notified vide Notification No. 08-Selection of 2025 dated 30.07.2025, under endorsement No. JKSSB-Scry/11/2025-06 (7704003) dated 30.07.2025.

Accordingly, the undersigned is directed to forward herewith the selection list of **10 posts** of Steno Typist, Health & Medical Education Department, District Cadre, advertised vide Notification No. 02 of 2021 dated 26.03.2021 under various Item Nos as per **Annexure "A"** to this communication.

The above Selection list shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction related to the selection. The Selection of the candidates has been made on the basis of Self-declaration/ Certificates submitted by them and if at any stage, it comes to the notice that any candidate(s) has submitted false information or has secured selection on the basis of fake or invalid document/ certificates, the selection shall be liable to cancellation at any stage and appropriate Criminal proceedings against such candidate/s may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates whose recommendation(s) are released by the Selection Agency shall submit their Personal Verification Rolls (PVR) before the appointing authority within a period of **21 days** from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
