The JKSSB conducted Computer Based Test (CBT) for the aforementioned post and based on the performance of the candidates, published the result/score sheet and called the candidates falling under the consideration zone for Document Verification.

Thereafter, the Selection Committee, constituted vide Office Order No. 164-SSB of 2023 dated 28.08.2023, prepared the Provisional Selection List which was notified vide No. JKSSB-SD0SECY(JMU)/2023/897-902 dated. 20.09.2023. The Board in its 241th meeting held on 18.10.2023, approved the Final Selection List for the aforementioned posts, which were notified, vide Notification No. JKSSB-SD0SECY(JMU)/2023/(E-7292733)/1020-25 dated. 03.11.2023.


