Consequent upon the receipt of indent/requisition from various departments, the Jammu and Kashmir Services Selection Board (JKSSB), among other posts advertised the **127** posts of Driver/Driver-II/ Tractor Driver/Truck Cleaner for UT, Divisional and various District Cadres for making direct recruitment to these posts as per following breakup:

Accordingly, the Final Selection List was notified vide Notification No. 20-Selection of 2024 dated 22.05.2025, and subsequently, forwarded to Animal/Sheep Husbandry & Fisheries Department vide letter dated 30.05.2024. Pertinently, the wait list in the instant selection was not forwarded along-with the select list, as regulation 68 of the Jammu and Kashmir Services Selection Board (Business and Procedure) Regulations, 2022, provides that for combined selections, the wait list shall be forwarded on the request of the Indenting Department.

The Animal/Sheep Husbandry & Fisheries Department, vide communication No. ASHF-AHONGAZ/29/2024 (C. No. 7639132) dated 02.05.2025, forwarded the requisition of 07 posts with the details for the post of Driver, Divisional/District Cadre, under Item Nos **158, 159, 162, 165 & 167**. Besides, the J&K Services Selection Board has also accrued one vacancy (**01 Post**) under Item No. 050 (OM Category), by cancelling the candidature of a candidate vide notification dated 20.02.2025, on account of his failure to fulfil the deficiency.

Consequent upon the above, the proposal for notifying the Wait List for the above said **08 posts** was placed in the 304th Board Meeting and subsequently, with the approval of the Board the Wait List was notified vide Notification No. JKSSB-Scry/4/2024-03 (E-711217) dated 23.05.2025.

Accordingly, the undersigned is directed to forward herewith the waiting list as per "**Annexure-A**" for the post of Driver, Division/District Cadre, under Item Nos **050, 158, 159, 162, 165 & 167** of Animal/Sheep Husbandry & Fisheries Department, advertisement No. 02 of 2022 dated 09.02.2022 & 04 of 2022 dated 27.07.2022, with the request to proceed in the matter accordingly. The other terms and conditions as conveyed vide this office letter No. JKSSB-Scry/4/2024-03 (E-7411217) Dated 30.05.2024, shall remain the same.

The above Waiting List shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Waiting Lists shall also be subject to the outcome of *inquiry*, involving candidates figuring in this Wait List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing Authority.

The Selection of the candidates in the wait list has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of invalid/fake/ deficient document(s) /certificate(s), the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates whose recommendation are released by the Selection Agency shall submit their Personal Verification Rolls (PVR) before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
