The J&K Services Selection Board (JKSSB) conducted the CBT Examination for the post of Patwari/Settlement Patwari (DMRRR) was held on 07.02.2023.

The Final Selection list for these post Patwari/Settlement Patwari (DMRRR) was approved by the Board in its 241th meeting held on 18.10.2023 and, notified vide No. JKSSB-SD0SECY(JMU)/2023/(E-7292733)/1020-25 dated. 03.11.2023 and subsequently forwarded vide No. JKSSB-SD0SECY(JMU)/2023/(E-7292733)/1029-33 dated 07.11.2023.




