Accordingly, the Final Selection List was notified vide Notification No. 20-Selection of 2024 dated 22.05.2025, and subsequently, forwarded to Transport Department vide letter dated 03.06.2024. Pertinently, the wait list in the instant selection was not forwarded along-with the select list, as regulation 68 of the Jammu and Kashmir Services Selection Board (Business and Procedure) Regulations, 2022, provides that for combined selections, the wait list shall be forwarded on the request of the Indenting Department.

The Transport Department, vide communication No. TRPT-SMGON/20/2021-02(77654) dated 11.10. 2024, forwarded the requisition with the details for **02 posts** of Driver-II, UT Cadre, under Item No. 121.

Consequent upon the above, the proposal for notifying the Wait List for the above said **02 post** was placed in the 304th Board Meeting and subsequently, with the approval of the Board the Wait List was notified vide Notification No. JKSSB-Scry/4/2024-03 (E-711217) dated 23.05.2025.

Accordingly, the undersigned is directed to forward herewith the waiting list as per "**Annexure-A**" for the post of Driver-II, UT Cadre, under Item No. 121 of Transport Department, advertisement No. 04 of 2022 dated 27.07.2022, with the request to proceed in the matter accordingly. The above Waiting List shall be subject to the outcome of writ petition(s)/OA(s), if any, pending disposal before any competent Court of jurisdiction. The Waiting List shall also be subject to the outcome of *inquiry*, involving candidates figuring in this Wait List.

The document verification/scrutiny conducted by the Board is limited to the extent of establishing physical possession of Category/Degree certificates and ascertaining genuineness/validity or otherwise of the same and recognition status of the Institution, shall be the responsibility of the Indenting Department/Appointing Authority.

The Selection of the candidates in the wait list has been made on the basis of Self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection on the basis of invalid/fake/ deficient document(s) /certificate(s), the selection shall be liable to cancellation at any stage and appropriate criminal proceedings against such candidate/s may kindly be initiated.

Moreover, in terms of Government Order No.1003-JK(GAD) of 2021 dated 27.09.2021, the candidates whose recommendation are released by the Selection Agency shall submit their Personal Verification Rolls (PVR) before the appointing authority within a period of 21 days from its release, failing which the candidate(s) shall forego their right to appointment forthwith.
