Whereas, the J&K Services Selection Board (JKSSB) received an Indent from Transport department for the posts of Motor Vehicle Inspector, Sub- Motor Vehicle Inspector and Assistant Motor Vehicle Inspector, UT/Divisional Cadre for making direct recruitment to these posts, as per following break up:

Whereas, the J&K Services Selection Board (JKSSB) advertised these 033 posts, vide Notification No. 04 of 2020 dated:16.12.2020, for seeking applications from the eligible candidates and the Computer Based Written Test (CBT) for these posts was held on 08.11.2021 to 12.11.2021; and

Whereas, Final Selection List for these posts of Motor Vehicle Inspector, Sub Motor Vehicle Inspector and Assistant Motor Vehicle Inspector was notified vide No. JKSSB-Scry/3/2023-03 (E-7180554) dated 26.06.2023 and forwarded to the Transport Department; and

Whereas, the Waiting List for these posts was not forwarded along-with the select list, as it was a combined selection and Regulation- 68 of the Jammu and Kashmir Services Selection Board (Business and Procedure) Regulations, 2022, provides that for such selections, the wait list shall be forwarded on the request of the Indenting Department. Meanwhile, the procedure of drawing up and forwarding the wait list (s) was discontinued vide S.O. 496 of 2023 dated 26.09.2023, which omitted sub rule (7) of Rule 14 of the Jammu and Kashmir Civil Services (Decentralization and Recruitment) Rules, 2010. However, in light of S.O 134 of 2024 dated 28th February, 2024, the provisions for preparation of the Waiting Lists have been revived; and



Whereas, the Selection Committee constituted for these posts, having regard to the candidature, merit/preference of the candidates, prepared Waiting List in respect of three (03) eligible candidates in the respective category/cadre, which was subsequently approved in the 273rd Board Meeting.

The Selection of the candidates has been made on the basis of self-declaration/Certificates submitted by them and if at any stage, it comes to the light that any candidate(s) has submitted false information or has secured selection in the list on the basis of false documents/certificates, the selection shall be liable to cancellation at any stage.
