NOTIFICATION

JKSSB-Scry/35/2025-03(E-7802335) dated 14.02.2026 but failed to appear for the medical examination due to various reasons.

Accordingly, such candidates are hereby directed to appear before the respective Medical Board either at Government Medical College (GMC), Jammu or at Government Medical College (GMC), Srinagar, as the case may be.

It is further notified that failure to appear before the Medical Board within the stipulated period shall entail rejection of the candidature of the concerned candidates, and no further claim, request or representation in this regard shall be entertained thereafter.
